Re.: Important Notice: Changes made to the prospectus of the T. Rowe Price Funds SICAV

Dear Shareholder,

We are writing to inform you of the following changes made to the prospectus of the T. Rowe Price Funds SICAV (the "Company") in the September 2021 update.

- 1) For each fund a classification or status under Sustainable Finance Disclosure Regulation (SFDR) has been added.
- 2) For the following funds, the benchmark has been amended/clarified as detailed below:

- 3) T. Rowe Price Singapore Private Ltd. has been added as sub-investment manager to the fund page of Emerging Markets Equity Fund. Additionally, effective 1 January 2022, the sub-investment manager may further, at its absolute discretion, assign the management of a portion of the assets of the fund to other entities of T. Rowe Price group, already approved by the CSSF as investment managers
- 4) The “Investment Process” section of the fund page for Global Growth Equity Fund has been amended to increase the expected number of companies in the portfolio to ‘130 to 160’ to ‘150 to 200’.
- 5) In the ‘Sub-Investment Manager’ section of the fund page of Global Real Estate Securities Fund, T. Rowe Price Associates, Inc. has been replaced as sub-investment manager by T. Rowe Price Hong Kong Ltd.
- 6) The ‘Sub-Investment Manager’ section of the fund page of Diversified Income Bond Fund has been removed to clarify that there is no longer any Sub-Investment Manager for the fund.
- 7) The table “Fund Derivatives Usage” has been amended to show that an additional main derivative type (detailed below) has been added for the following sub-funds:

None of these amendments represent a material change to the investment strategy of any fund.
