



Notice of the Sources of Fund Distributions

Dear Investor,

Section 19(a) of the Investment Company Act of 1940 requires the payment of any distribution to be accompanied by a written notice that discloses the sources of a payment if it is made from any source other than the fund's net income. This notice is intended to satisfy the requirements under Section 19(a).

T. Rowe Price Retirement Income 2020 Fund declared a \$0.0421 monthly distribution to shareholders of record on February 15, 2022 and paid on February 17, 2022. This notice provides an estimated breakdown of the sources of the distribution.

As of the prior month end, the amount of accumulated net realized gains/(losses) of the fund is \$151,291, \$0.01 per share, and the net unrealized appreciation/(depreciation) of portfolio securities is \$11,285,683, \$0.84 per share. While the amounts above are determined generally based on tax requirements, please note that they are estimates and are not for tax reporting purposes. The tax character of distributions made during the year will be determined at year-end and, for taxable shareholders, will be reported on your Form 1099-DIV mailed by mid-February of the following year.
