NOTICE TO SINGAPORE SHAREHOLDERS

T. ROWE PRICE FUNDS SICAV (the "Company") **- Global High Yield Bond Fund (the "fund")**

We refer to the above fund, which is recognised in Singapore by the Monetary Authority of Singapore (the "**Authority**") pursuant to section 287 of the Securities and Futures Act 2001.

We are writing to inform you that, effective 1 October 2026:

1. the name of the Global High Yield Bond Fund changes to High Yield Bond Fund. The proposed change removes the word "global" from the fund's name to better reflect the fund's increasing exposure to US-denominated bonds while maintaining flexibility to be more diversified and invest globally. This change does not impact the fund's portfolio composition, its investment strategy nor risk profile.
2. Change of the benchmark used by the Global High Yield Bond Fund (to be renamed to High Yield Bond Fund effective 1 October 2026) from J.P. Morgan Global High Yield Index to Bloomberg US HY 2% Issuer Constrained Index. The purpose of the benchmark will remain performance comparison.

These amendments represent a material change to the fund mentioned and will be effective as of the date indicated above and in the Singapore prospectus of the Company.

We are writing to inform you of the following changes made to the prospectus of the T. Rowe Price Funds SICAV (the “**SICAV**”) in the July 2026 update.

- 1) Addition of T. Rowe Price Associates, Inc as the sub-investment manager of the Multi-Asset Global Income Fund, effective 1 June 2026.
- 2) Addition of T. Rowe Price Australia Limited as the sub-investment manager of the Global Real Estate Securities Fund, effective 1 July 2026.
- 3) Additional information regarding the Towards Sustainability label granted to the US Impact Equity Fund on its fund page in the prospectus and in its sustainability annex.
- 4) Clarification regarding exclusion screening and the use of Paris-aligned benchmark exclusions used in the US Equity Fund in its sustainability annex.
- 5) Removal of the Asian Opportunities Equity Fund following its merger into the Asian ex-Japan Equity Fund on 12 June 2026.
- 6) Addition of new share classes and their fees for the following funds:
 - Retirement Allocation Fund 1
 - Retirement Allocation Fund 2
 - Retirement Allocation Fund 3.
- 7) Clarification regarding the integration of the analysis of governance and sustainability factors into the investment process of the SICAV's sub-funds on relevant sub fund pages.
- 8) Clarification and renaming of the current 'Environmental, Social, Governance Risk' to 'Sustainability Risk.' Clarification and renaming of the current 'Sustainability Risk' as 'Sustainability Alignment Product Risk,' which is applicable to sub-funds that have a sustainable investment objective or that seek to promote environmental and/or social characteristics.
- 9) Addition of Mr Barnaby Liddon Taylor as a conducting officer of the SICAV's management company.

- 10) General updates, amendments and clarifications of wording and any other changes driven by applicable laws and regulations and/or by the regulator.

None of these amendments represent a material change to the investment strategy of any fund.
