INVESTMENT APPROACH

- Focus on companies within the market cap range of the Russell MidCap Growth Index, generally between \$3 billion and to \$30 billion (USD) at time of purchase.
- Concentrate on companies with expected annual growth rates greater than 12%.
- Require solid financial characteristics and financial flexibility to hedge against the operational risk endemic to faster growing companies.
- Integrate fundamental research to identify companies with strong management and attractive business models that can deliver above-average earnings growth.
- Broadly diversify holdings to manage portfolio risk profile.
- Integrate relative valuation assessment to weigh valuation versus expected growth.
- Stay focused on the long term — employ a low turnover, patient trading strategy.
- Mid-cap growth company stocks are generally more volatile than stocks of large, well-established companies. Diversification cannot assure a profit or protect against loss in a declining market.

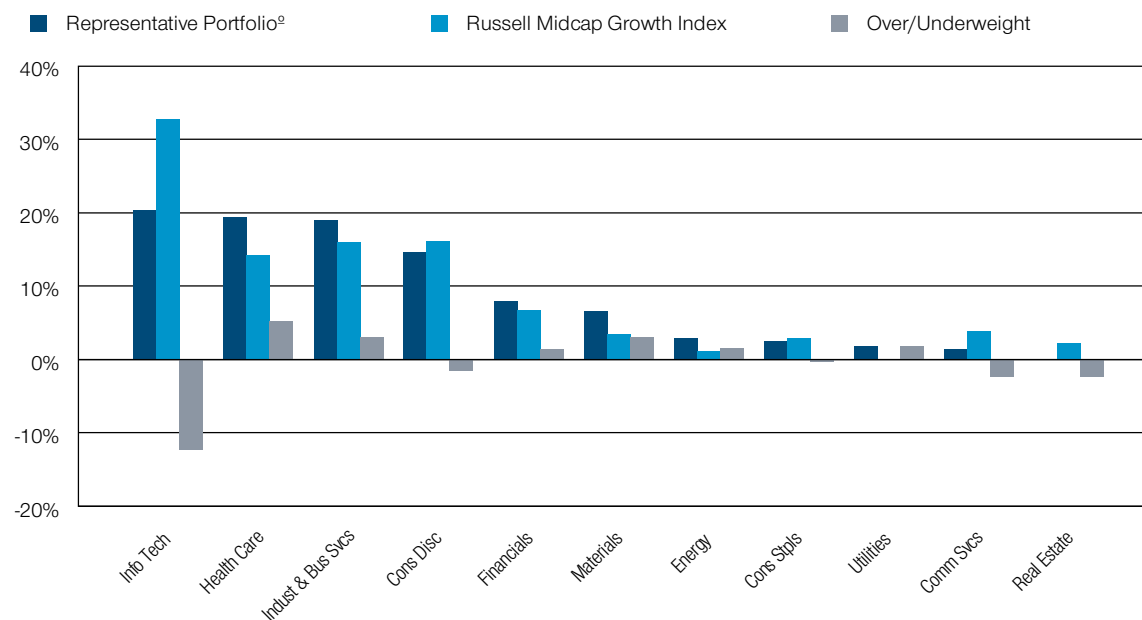

Verification does not ensure the accuracy of any specific composite presentation.
