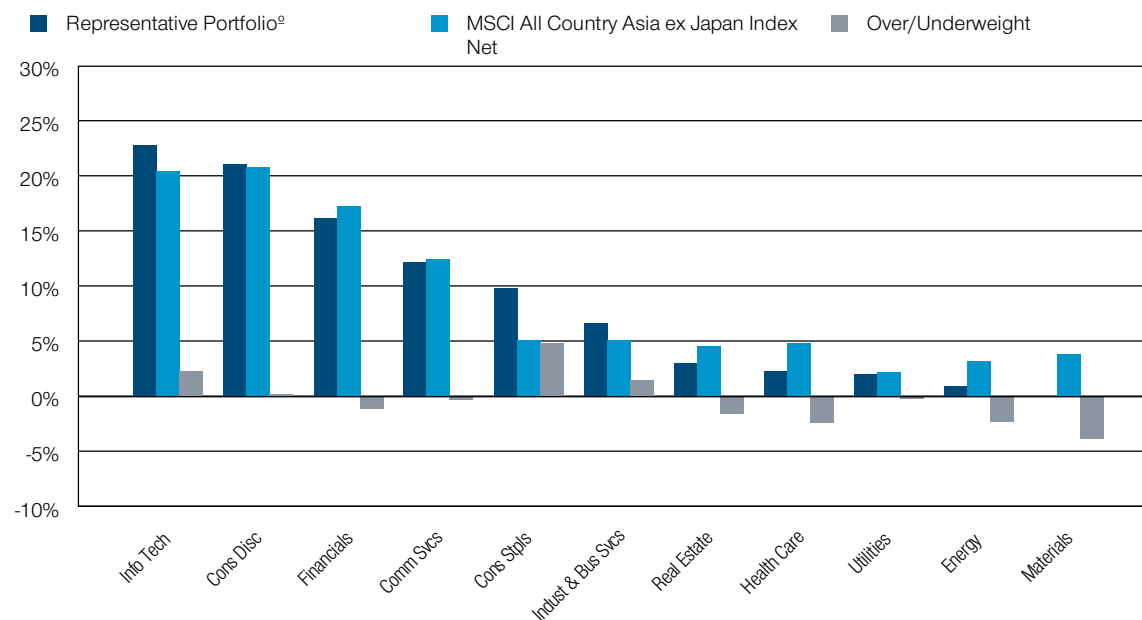

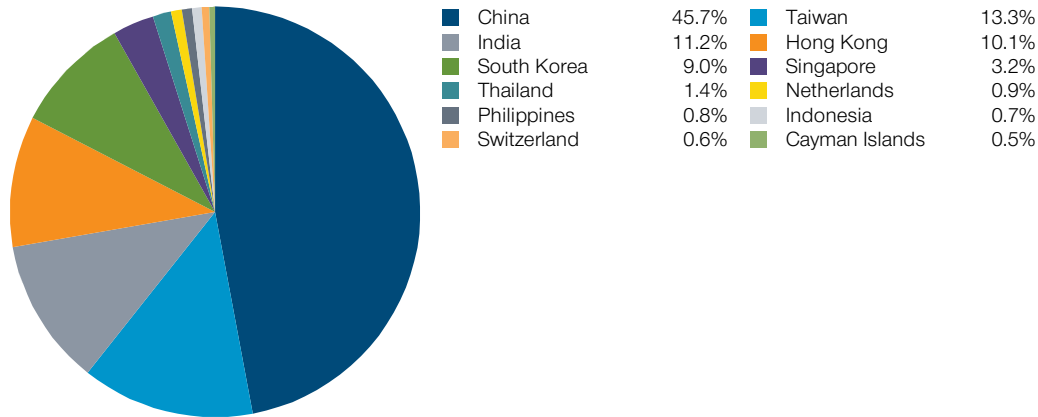

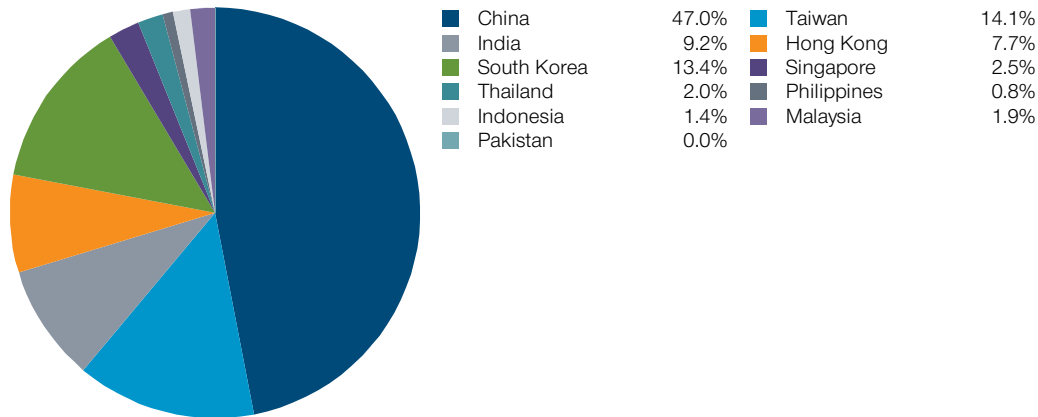

Representative Portfolio²

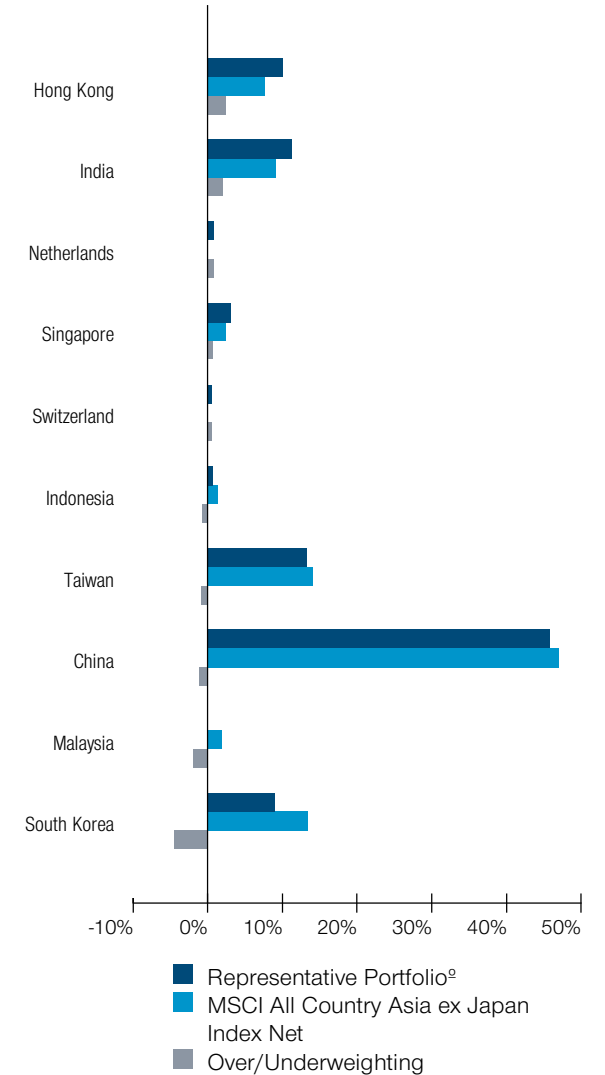


MSCI All Country Asia ex Japan Index Net

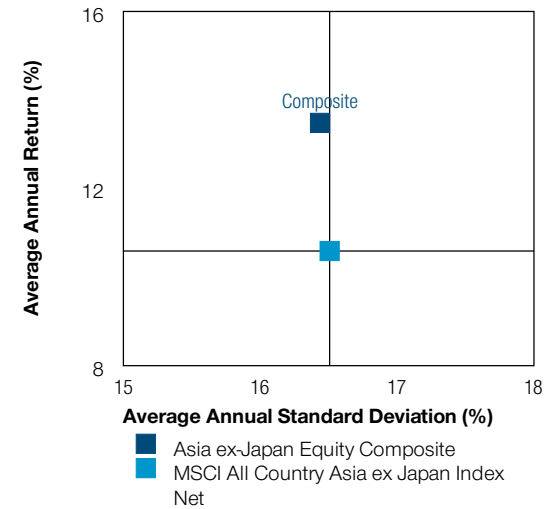
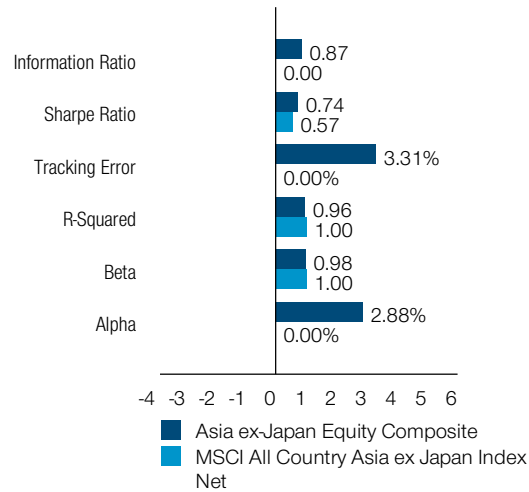
