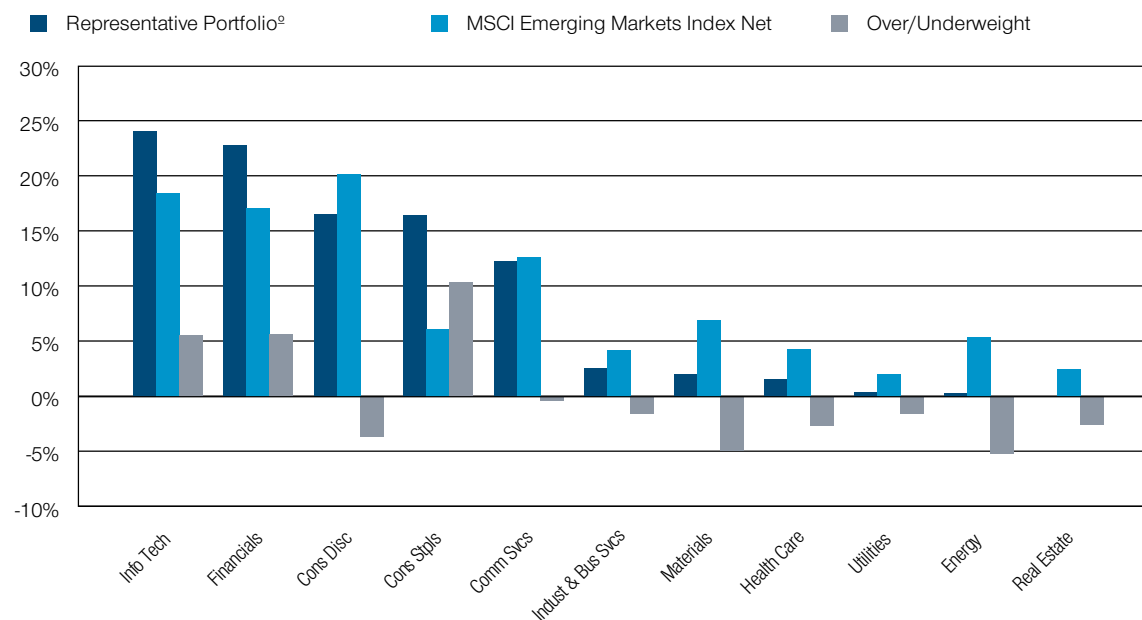

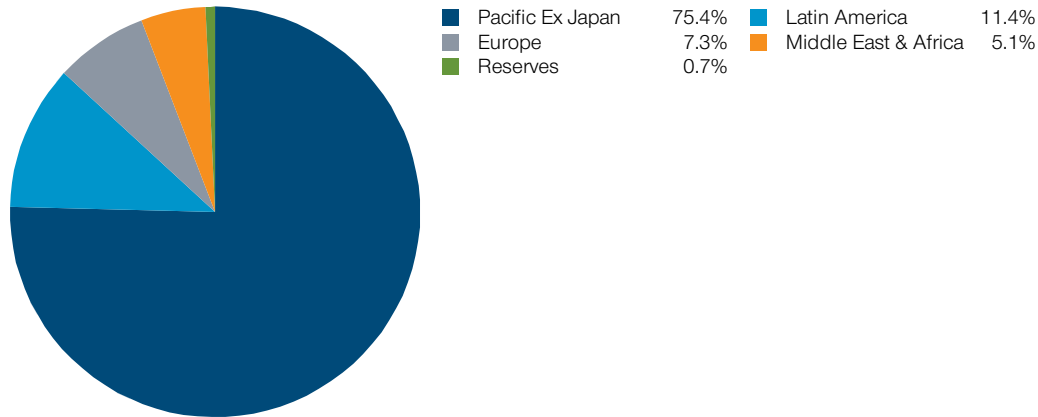

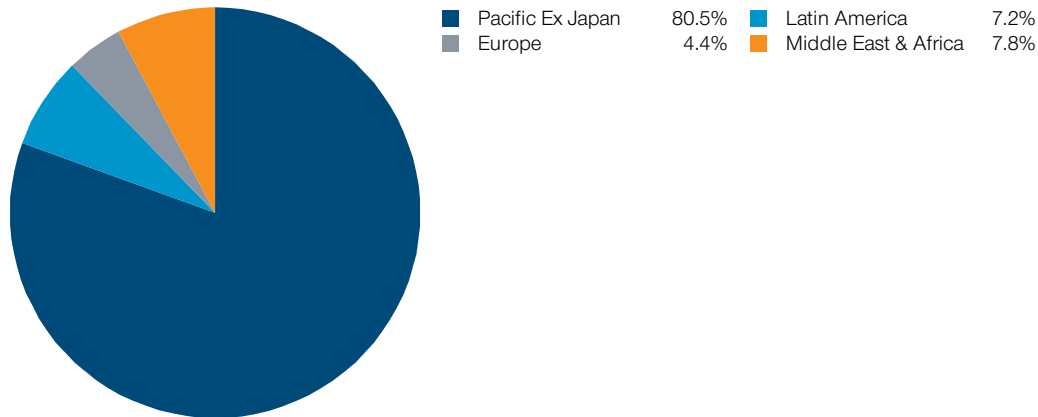

Representative Portfolio⁹

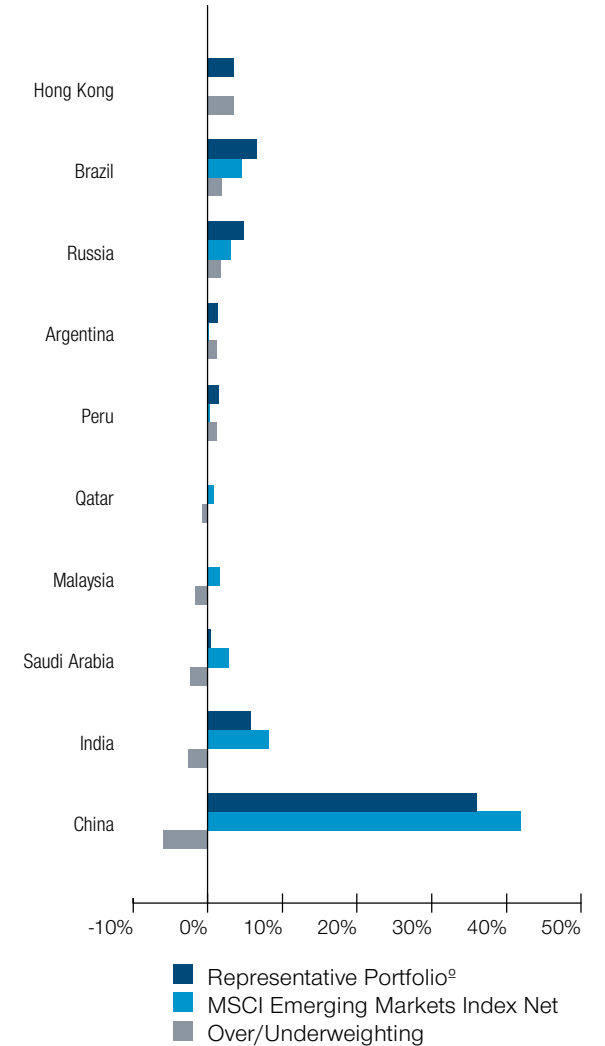


MSCI Emerging Markets Index Net

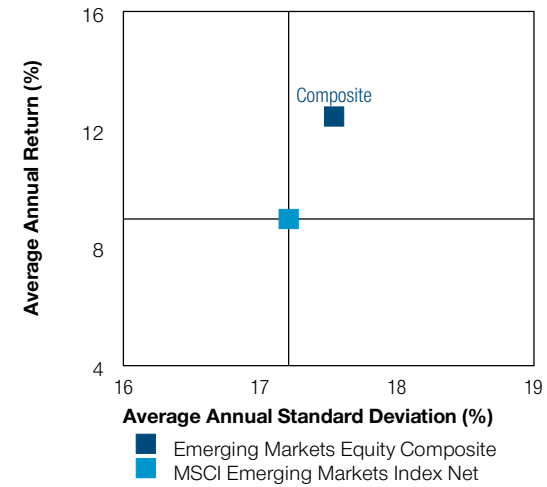
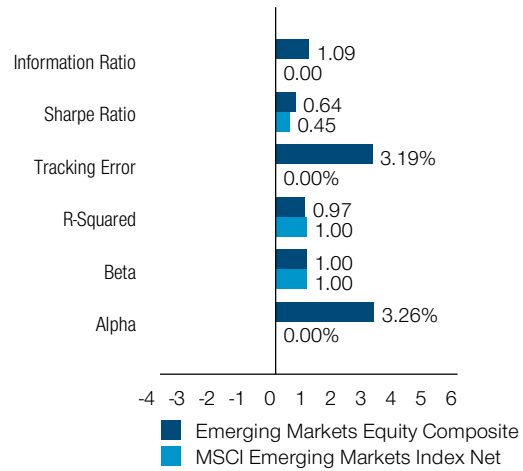
