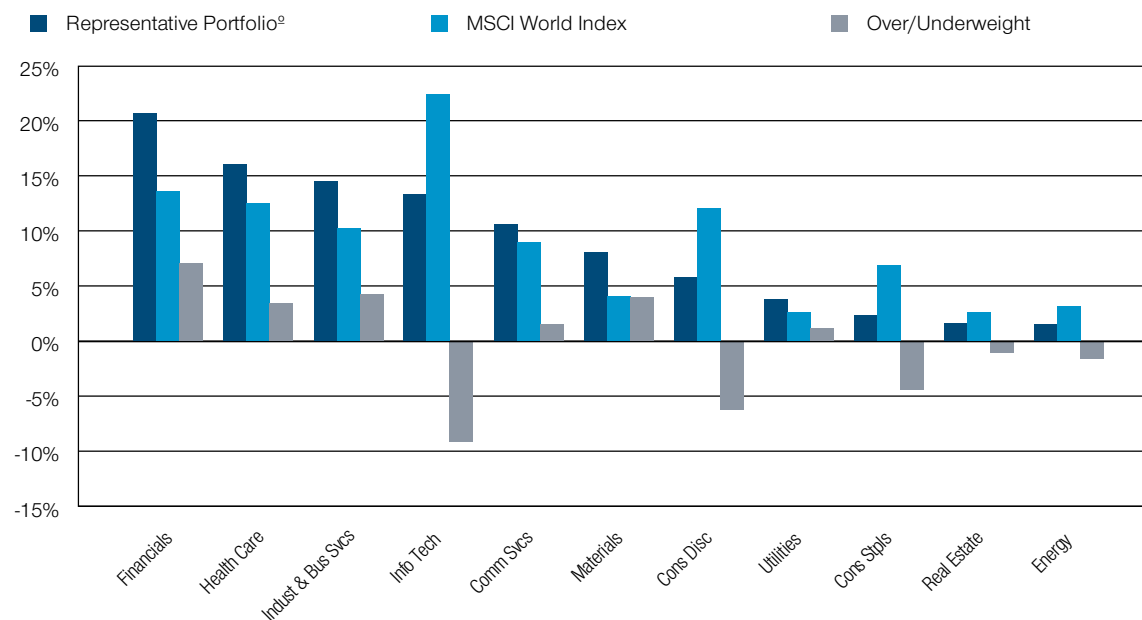

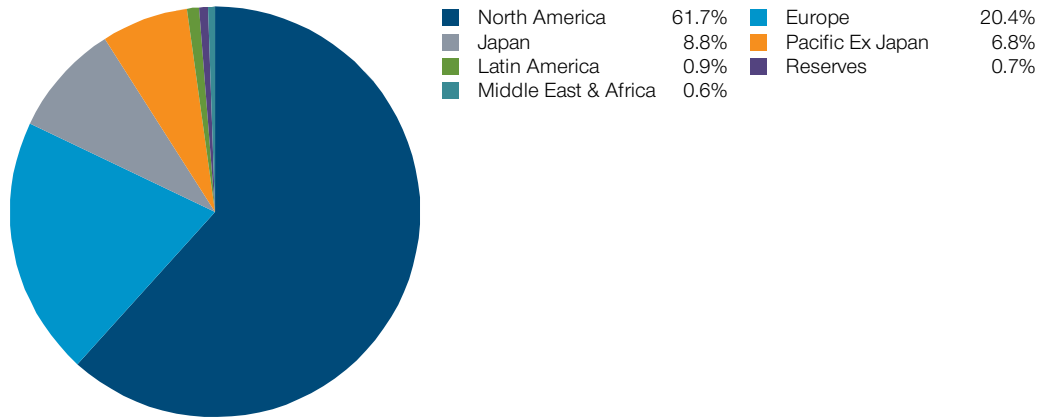

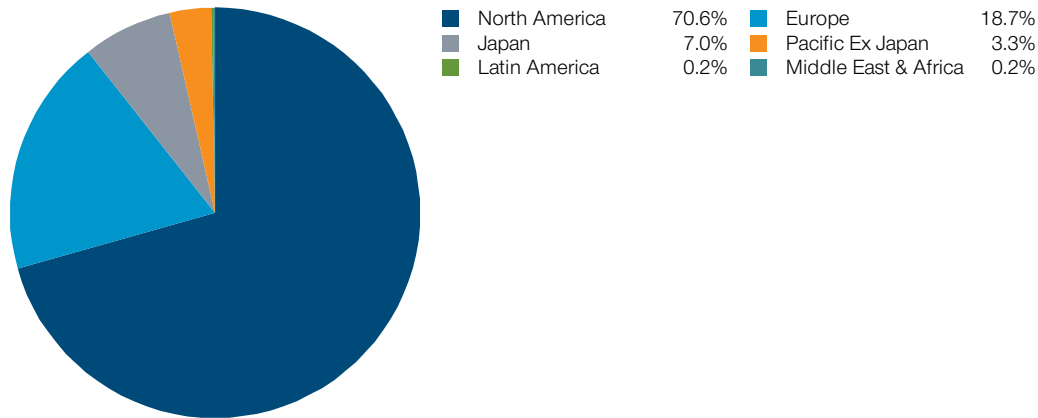

Representative Portfolio⁹

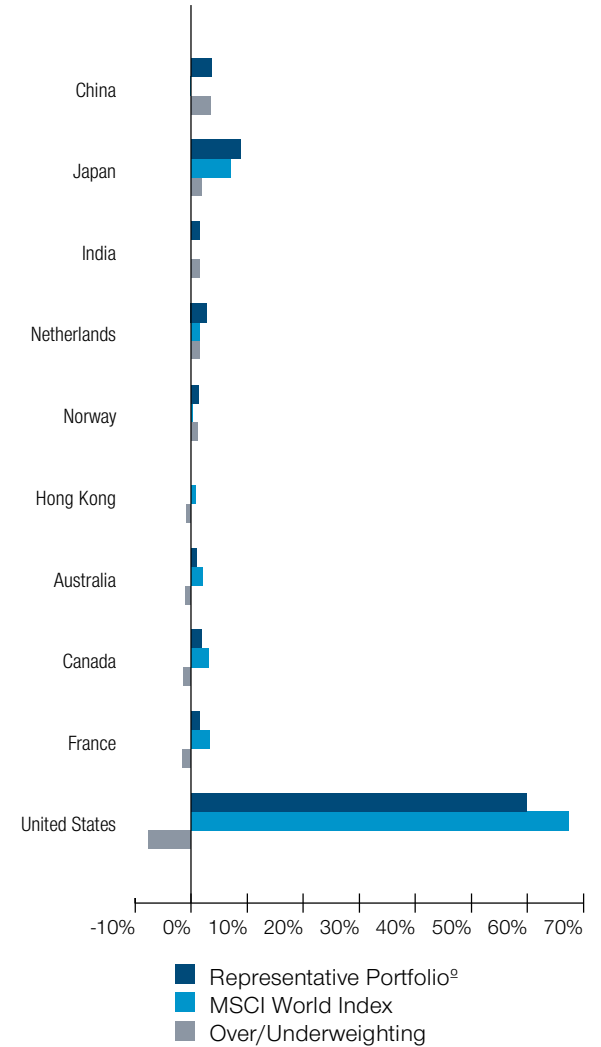


MSCI World Index

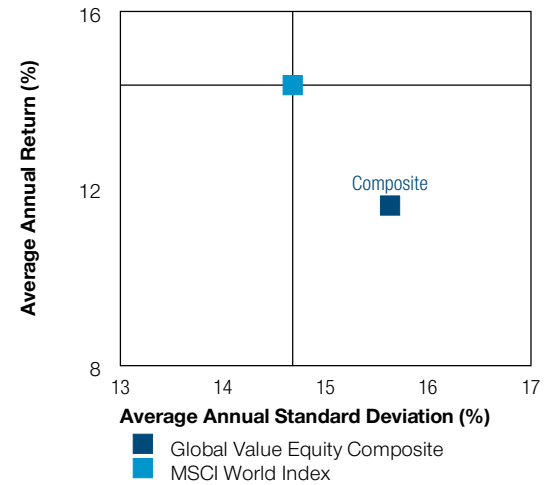
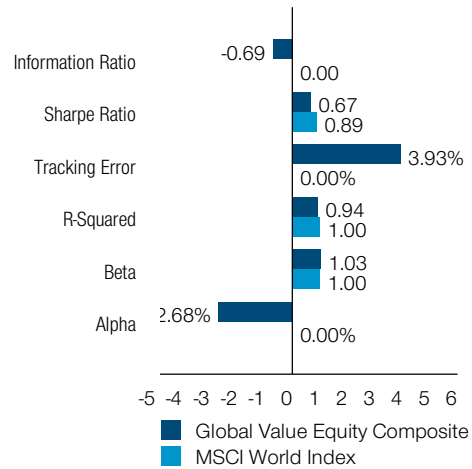
