## INVESTMENT OBJECTIVE

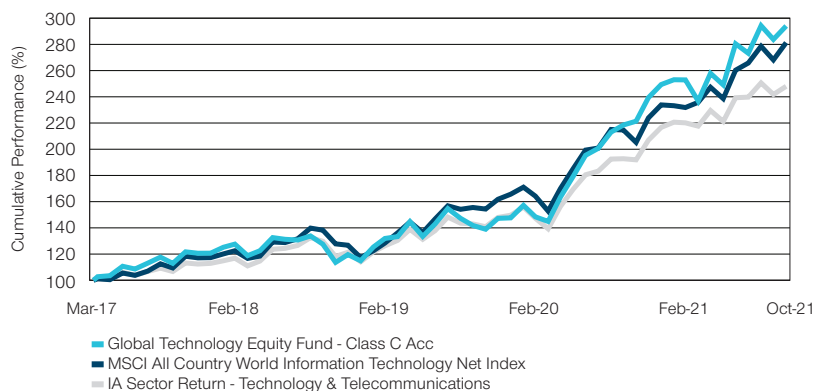

## KEY FUND RISKS
