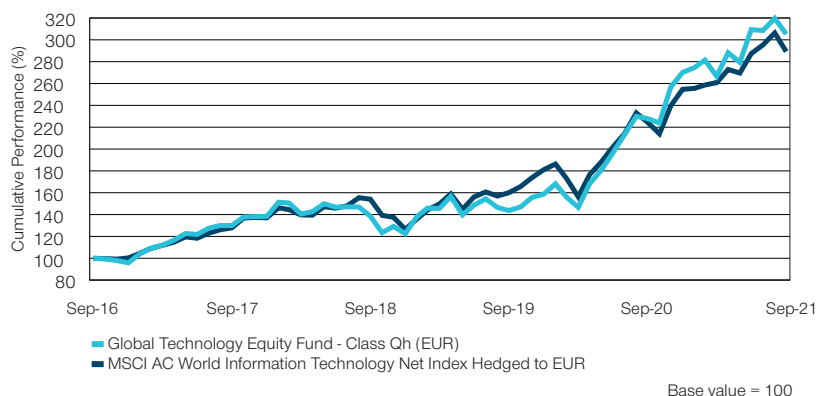
INVESTMENT OBJECTIVE
