

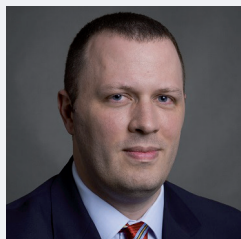

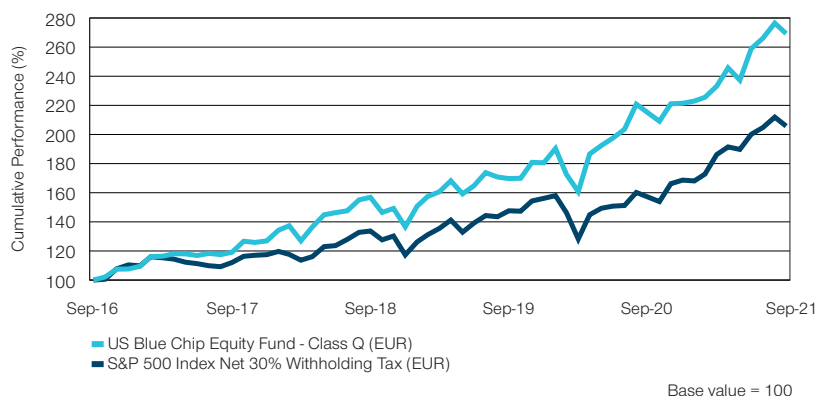


Effective 1 October 2021, Paul Greene assumed sole portfolio management responsibility for the fund.
