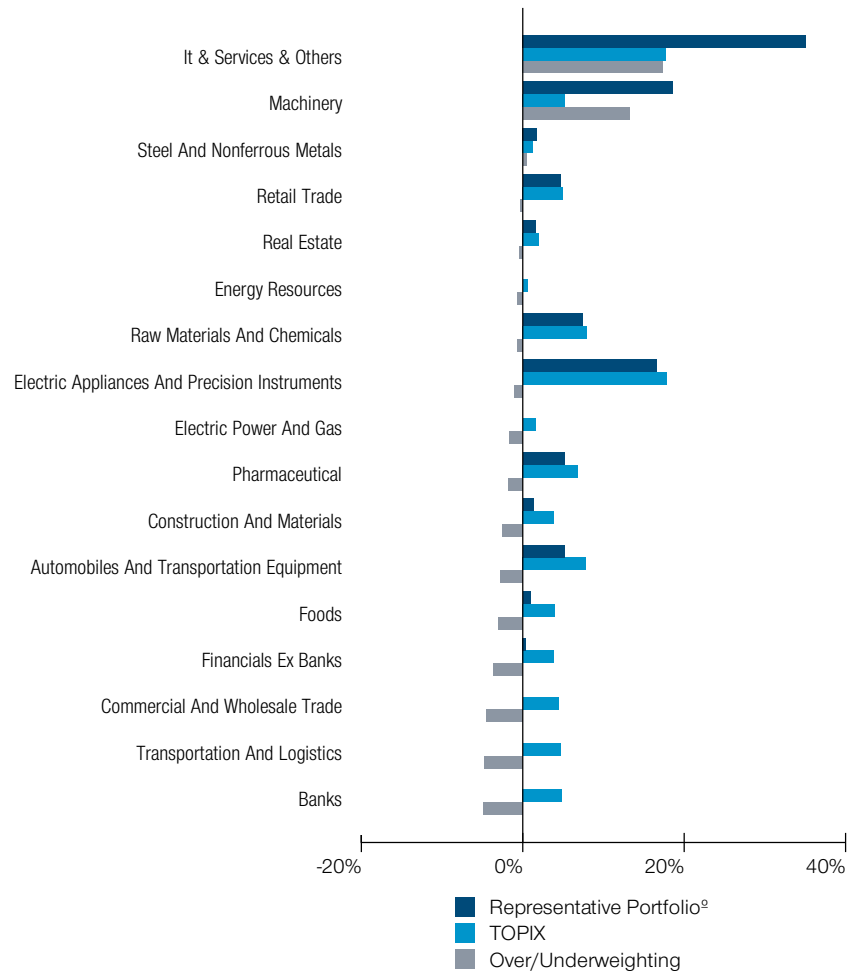

SECTOR DIVERSIFICATION

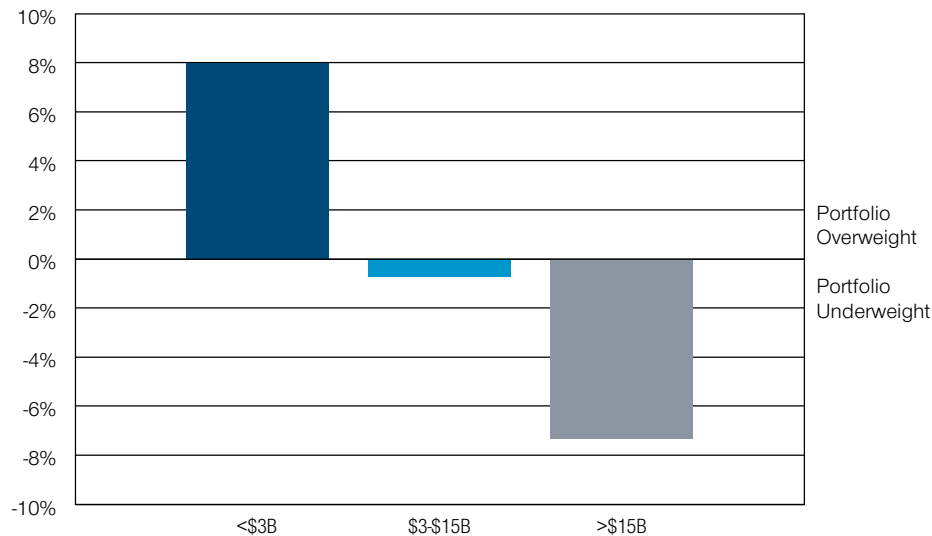
Sector Overweight/Underweight Positions (Sorted by Representative Portfolio Relative Weight)

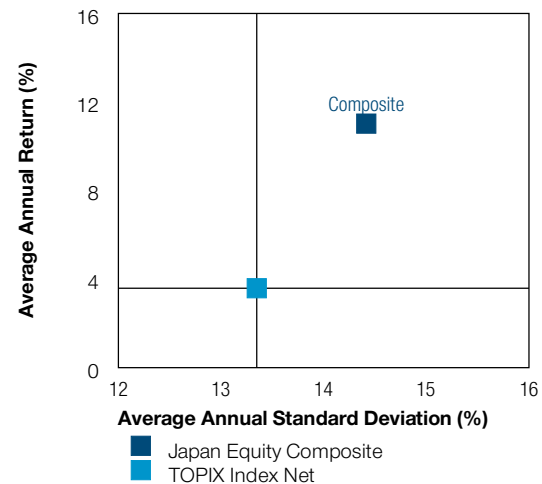
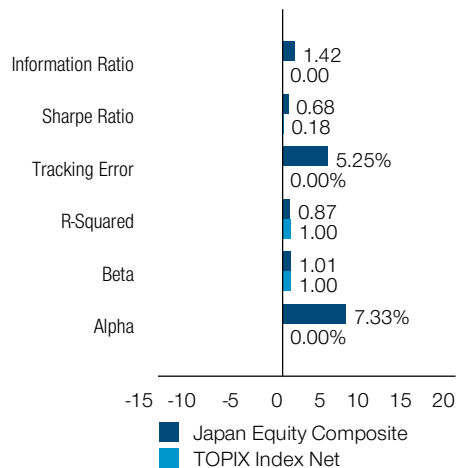

Dispersion is measured by the standard deviation across asset-weighted portfolio returns represented within a composite for the full year. Dispersion is not calculated for the composites in which there are five or fewer portfolios.

The temporary removal of such an account occurs at the beginning of the measurement period in which the significant cash flow occurs and the account re-enters the composite on the last day of the current month after the cash flow. A portfolio management change occurred effective December 27, 2013. There were no changes to the investment program or strategy related to this composite.
