Rowe Price proprietary Responsible Investor Indicator Model (RIIM). In addition to the E/s characteristics promoted, the fund also applies the investment manager's proprietary responsible screen (the T. Rowe Price Responsible Exclusion List). The fund may use derivatives for hedging, efficient portfolio management and investment purposes. The fund may also use derivatives to create synthetic short positions in currencies, debt securities, credit indices and equities. The investment policy of the fund changed as at 1 October 2022, with the addition of a minimum commitment to sustainable investments. The performance prior to this date was achieved without this consideration.

Effective 1 November 2021, the fund changed its comparator benchmark from the 3-month GBP LIBOR to the SONIA 3 Month Sterling Interbank Lending Rate (Midpoint) in anticipation of the transition away from use of LIBOR settings. Historical benchmark representations have not been restated.
