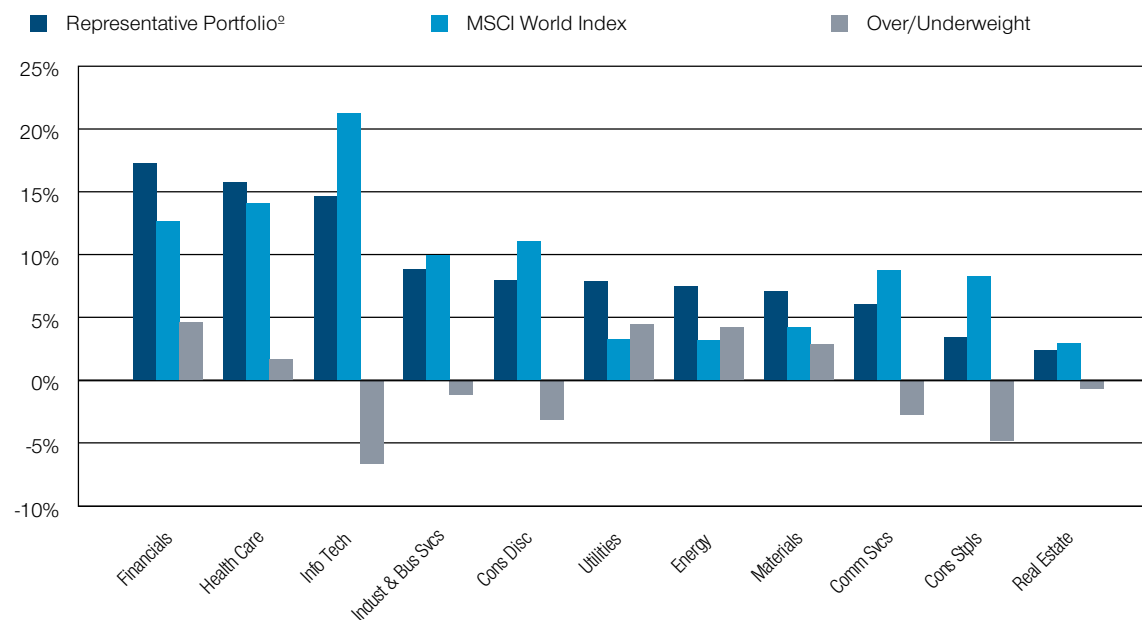

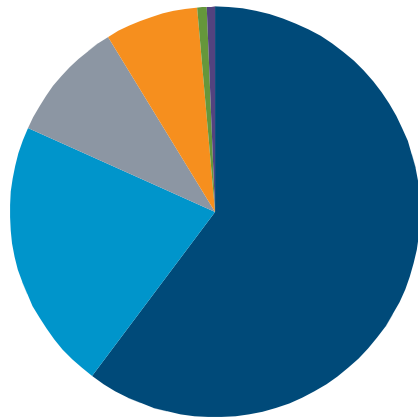

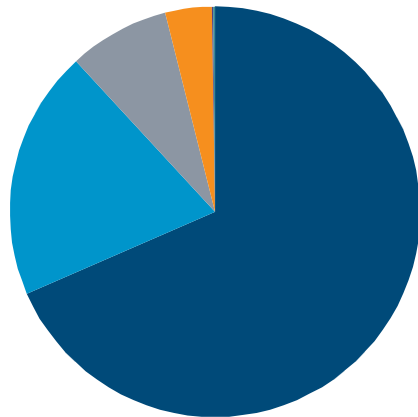
**GEOGRAPHICAL DIVERSIFICATION**

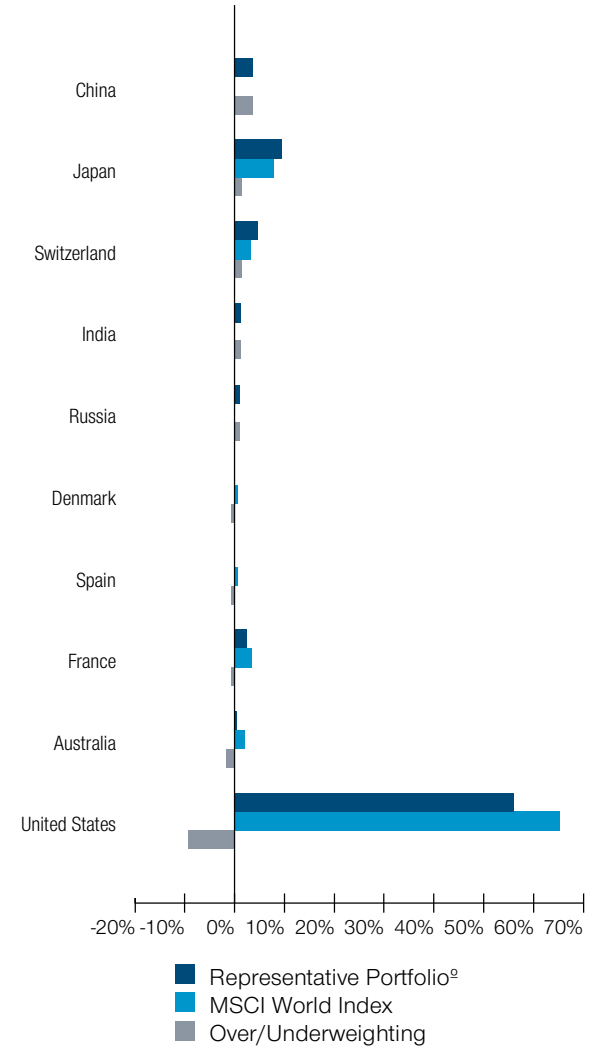

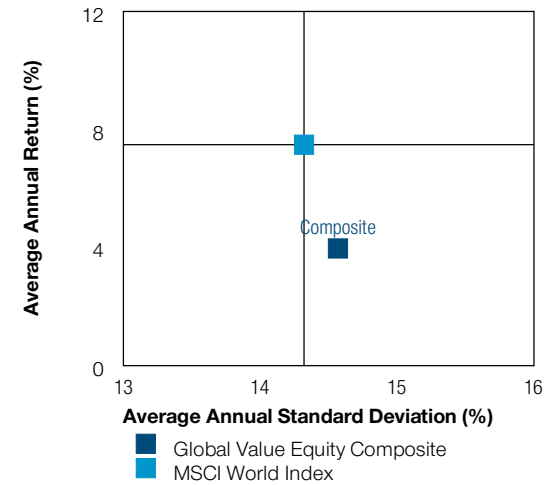
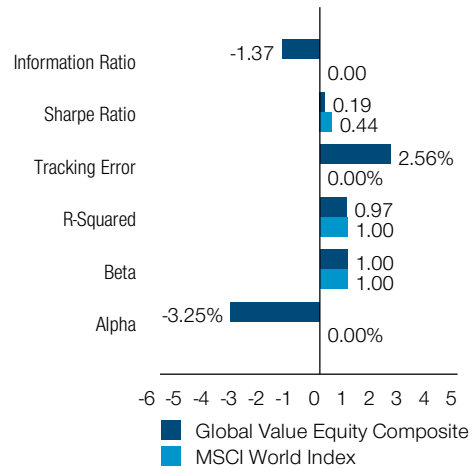
