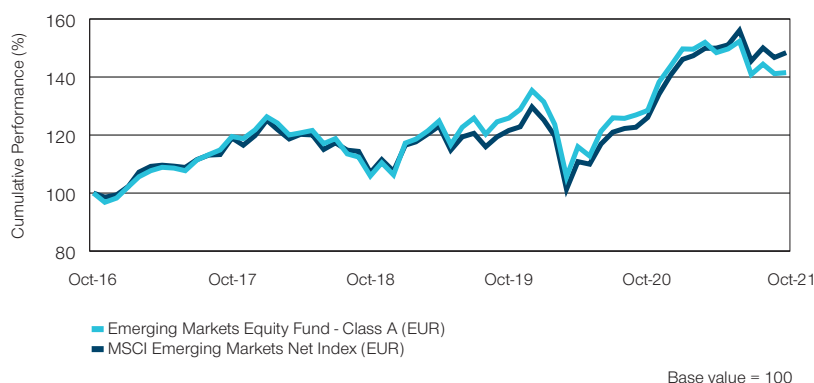

KEY FUND RISKS
