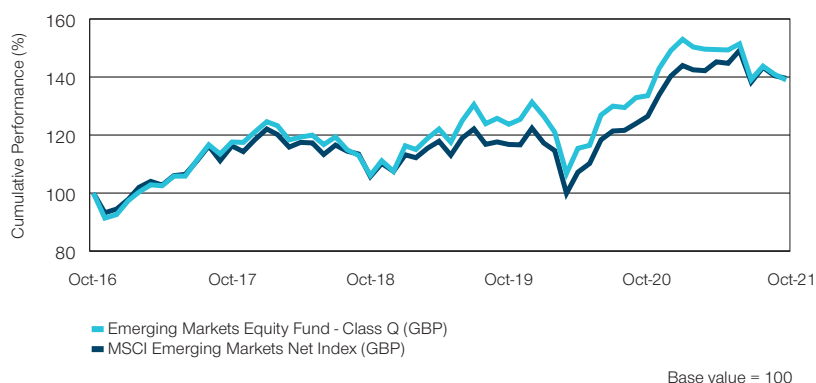

## KEY FUND RISKS
