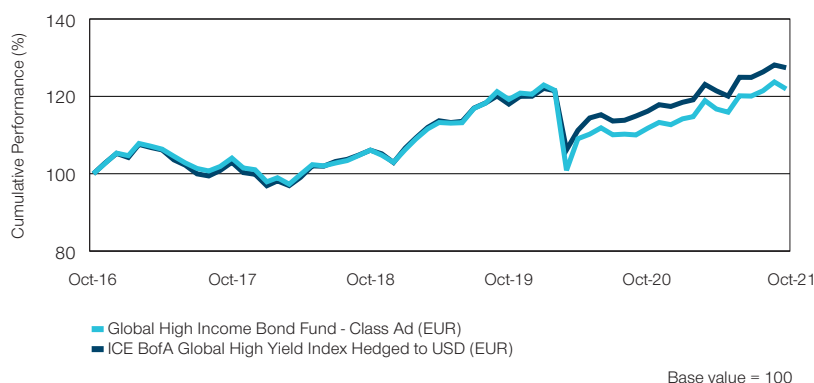

**KEY FUND RISKS**
