

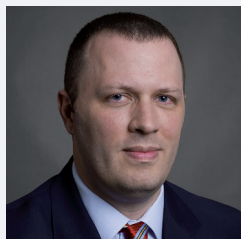

INVESTMENT OBJECTIVE

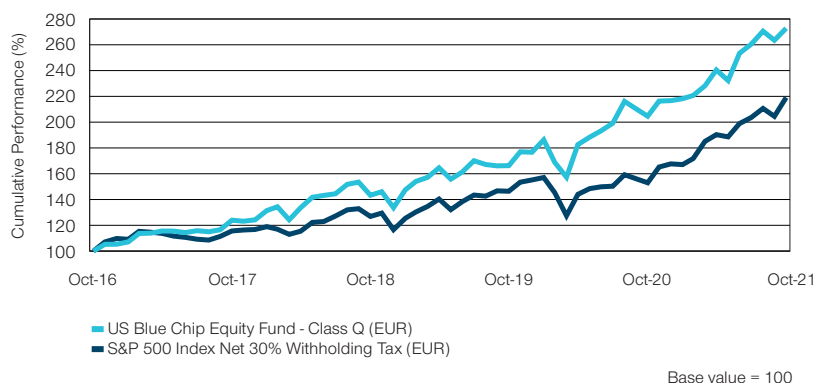
