We employ a dynamic, risk aware strategy to help balance factor exposures and economic sensitivities while emphasizing stock-specific opportunities. The portfolio seeks to own durable and resilient companies with clear reasons for why we believe they are expected to benefit. By building the portfolio from the bottom up and taking a multi-faceted view of risk, we aim to avoid unintended macro variables.
