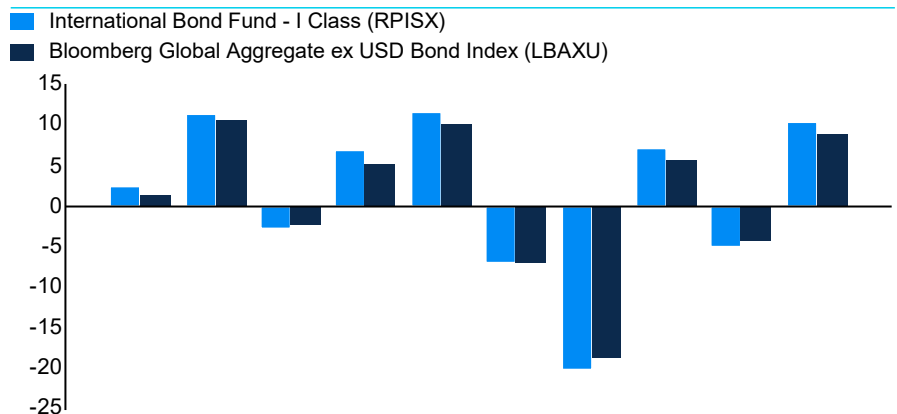
Investment Objective & Strategy

The fund seeks to provide current income and capital appreciation.

The fund will normally invest at least 80% of its assets in foreign bonds. It may also invest up to 25% in below investment-grade bonds and up to 20% in U.S. dollar-denominated bonds.

The fund normally does not attempt to hedge its currency exposure—"pure play" exposure to the international bond markets.

Morningstar rated the fund 2, 1, and 2 stars among 146, 141 and 123 Global Bond funds for the 3-, 5-, and 10-year periods (as applicable) ending 3/31/2026, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.

Fund Assets, holdings-based analytics (excluding portfolio turnover), and portfolio attribution are calculated using T. Rowe Price's internal Investment Book of Records (IBOR). If a rating is not available, the security is classified as Not Rated (NR). T.
