## Investment Objective & Strategy

The fund seeks income by investing in inflation-linked securities.

Aims to closely track the investment returns of its benchmark index, the Bloomberg U.S. 1-5 Year Treasury TIPS Index.

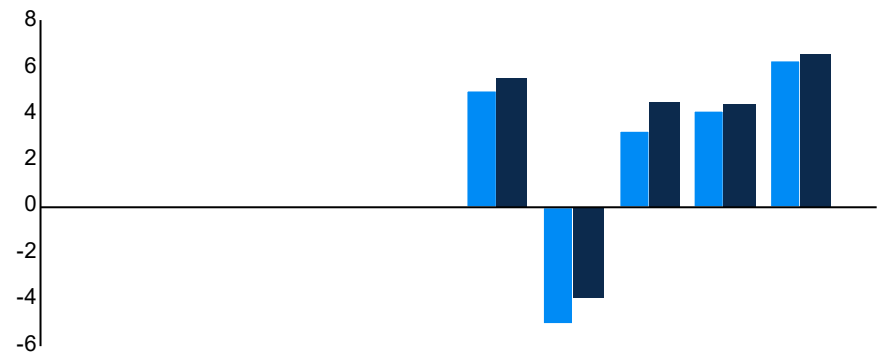
Under normal conditions, the fund is actively managed and invests at least 80% of its net assets in short-term Treasury Inflation Protected Securities that are held in the index.

The fund normally maintains a duration of between one and five years, which will vary based on changes in the composition of the index.

Morningstar rated the fund 2 and 2 stars among <RMS\_Morningstar\_Fund\_Count\_Year03> and <RMS\_Morningstar\_Fund\_Count\_Year05> Short-Term Inflation-Protected Bond funds for the 3- and 5-year periods (as applicable) ending 3/31/2026, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.

Fund Assets, holdings-based analytics (excluding portfolio turnover), and portfolio attribution are calculated using T. Rowe Price's internal Investment Book of Records (IBOR). Due to timing and accounting methodology differences, IBOR data may differ from the Accounting Book of Records (ABOR) data provided by the Fund's accountant. T. Rowe Price uses a custom structure for sector and industry reporting for this product. Diversification exhibits may not add to 100% due to exclusion or inclusion of cash. A rating of "AAA" represents the highest-rated securities, and a rating of "D" represents the lowest-rated securities. If the rating agencies differ, the highest rating is applied to the security. If a rating is not available, the security is classified as Not Rated (NR). T.
