The fund seeks to provide long-term capital growth by investing primarily in stocks of small companies.

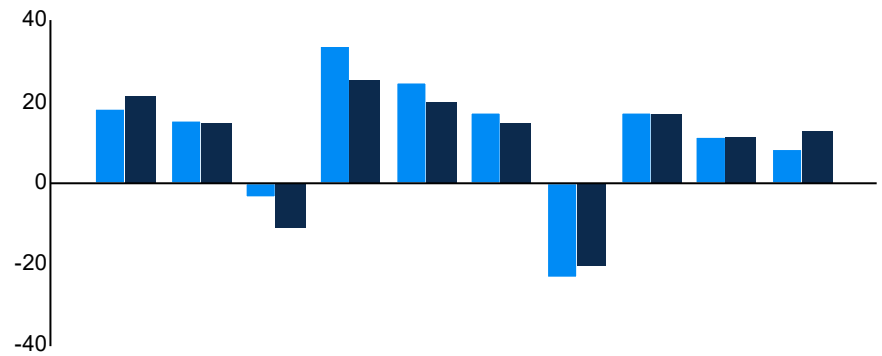
The fund seeks to temper the generally higher risk of small-company stocks by investing in both growth- and value-oriented securities.

Morningstar rated the fund 4, 4, and 4 stars among 522, 500 and 399 Small Growth funds for the 3-, 5-, and 10-year periods (as applicable) ending 3/31/2026, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.
