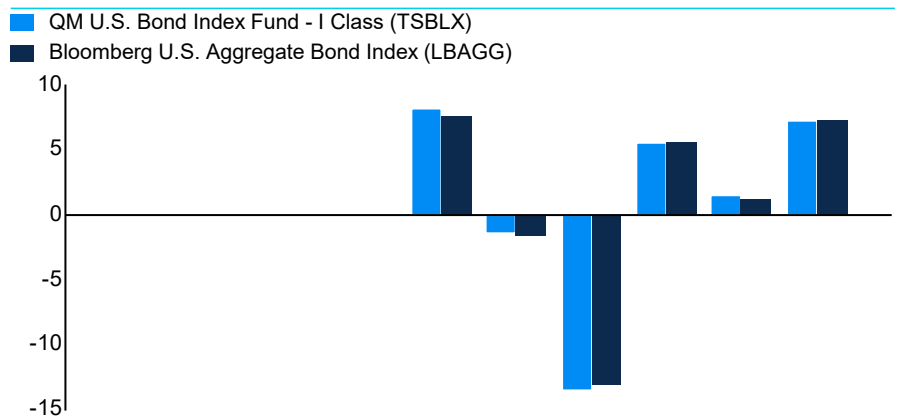

Investment Objective & Strategy

The fund seeks to provide a total return that matches or incrementally exceeds the performance of the U.S. investment-grade bond market.

The fund seeks to provide a total return on a net of fees basis that matches or incrementally exceeds the performance of the U.S. investment-grade bond market, as represented by the Bloomberg U.S. Aggregate Bond Index. It seeks to do so by exploiting persistent inefficiencies within the benchmark in order to generate an incremental yield advantage while replicating the benchmark's key risk factors to minimize tracking error. Our process is primarily driven by quantitative methodology supplemented with fundamental credit research to drive security selection.

Morningstar rated the fund 3 and 3 stars among 417 and 377 Intermediate Core Bond funds for the 3- and 5-year periods (as applicable) ending 3/31/2026, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.

Fund Assets, holdings-based analytics (excluding portfolio turnover), and portfolio attribution are calculated using T. Rowe Price's internal Investment Book of Records (IBOR). Due to timing and accounting methodology differences, IBOR data may differ from the Accounting Book of Records (ABOR) data provided by the Fund's accountant. T. Rowe Price uses a custom structure for sector and industry reporting for this product. Diversification exhibits may not add to 100% due to exclusion or inclusion of cash. Credit ratings for the securities held in the Fund are provided by Moody's, Standard & Poor's and Fitch and are converted to the Standard & Poor's nomenclature. A rating of "AAA" represents the highest-rated securities, and a rating of "D" represents the lowest-rated securities. If the rating agencies differ, the highest rating is applied to the security. If a rating is not available, the security is classified as Not Rated (NR). T.
