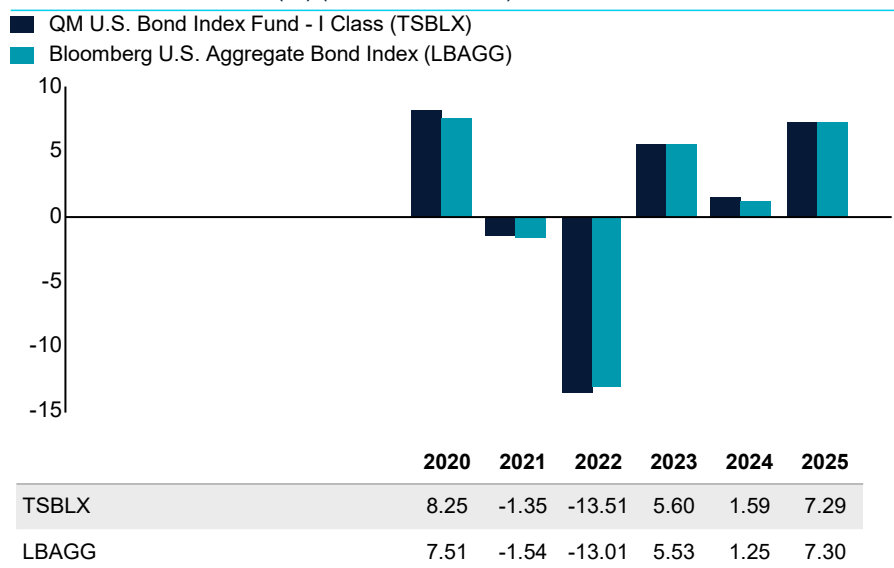

## Investment Objective & Strategy

The fund seeks to provide a total return that matches or incrementally exceeds the performance of the U.S. investment-grade bond market. The fund seeks to provide a total return on a net of fees basis that matches or incrementally exceeds the performance of the U.S. investment-grade bond market, as represented by the Bloomberg U.S. Aggregate Bond Index. It seeks to do so by exploiting persistent inefficiencies within the benchmark in order to generate an incremental yield advantage while replicating the benchmark's key risk factors to minimize tracking error. Our process is primarily driven by quantitative methodology supplemented with fundamental credit research to drive security selection.

Morningstar rated the fund 3 and 3 stars among 414 and 374 Intermediate Core Bond funds for the 3- and 5-year periods (as applicable) ending 12/31/2025, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.

Fund Assets, holdings-based analytics (excluding portfolio turnover), and portfolio attribution are calculated using T. Rowe Price's internal Investment Book of Records (IBOR).
