INVESTMENT OBJECTIVE AND STRATEGY

The fund seeks high income and, secondarily, capital appreciation.

The fund normally invests primarily in global, below-investment grade corporate debt securities:

- at least 80% of its net assets in bonds; up to 20% of net assets in bank loans.
- in credit instruments issued by corporations with operations in the U.S., Europe and emerging markets with U.S. exposure approximately 50% depending on market conditions.

BENEFITS AND RISKS

The fund seeks to deliver greater income potential than traditional higher quality fixed income securities in exchange for higher credit risk.

Provides investors access to a fully global corporate high yield opportunity set.


Hedges non-U.S. dollar denominated securities to help mitigate potential foreign exchange risk.

Definitions

Beta: A measure of market risk of an investment option that shows how responsive the investment is to a given market index, such as the Standard & Poor's 500 Index. By definition, the beta of the benchmark is 1.00. An investment with a beta of 1.10 is expected to perform 10% better than the index in up markets and 10% worse in down markets. Usually, higher betas represent riskier investments. Figures are calculated using monthly data and are net of fees.

Morningstar rated the fund 3 and 3 stars among 606 and 575 High Yield Bond funds for the 3- and 5-year periods (as applicable) ending 3/31/2024, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.
