## INVESTMENT OBJECTIVE AND STRATEGY

The fund seeks high income and, secondarily, capital appreciation.

- The fund normally invests primarily in global, below-investment grade corporate debt securities:
  - at least 80% of its net assets in bonds; up to 20% of net assets in bank loans.
  - in credit instruments issued by corporations with operations in the U.S., Europe and emerging markets with U.S. exposure approximately 50% depending on market conditions.

## BENEFITS AND RISKS

The fund seeks to deliver greater income potential than traditional higher quality fixed income securities in exchange for higher credit risk.

Provides investors access to a fully global corporate high yield opportunity set.

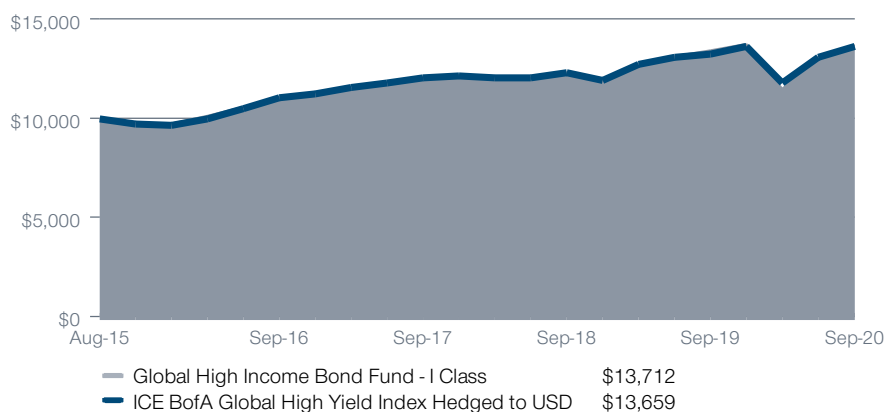
Hedges non-U.S. dollar denominated securities to help mitigate potential foreign exchange risk.

## Definitions

Beta: A measure of market risk of an investment option that shows how responsive the investment is to a given market index, such as the Standard & Poor's 500 Index. By definition, the beta of the benchmark is 1.00. An investment with a beta of 1.10 is expected to perform 10% better than the index in up markets and 10% worse in down markets. Usually, higher betas represent riskier investments. Figures are calculated using monthly data and are net of fees.

## Additional Disclosures

Morningstar rated the fund 3 and 5 stars among 620 and 534 High Yield Bond funds for the 3- and 5-year periods (as applicable) ending 9/30/2020, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.
