INVESTMENT OBJECTIVE AND STRATEGY

The fund seeks high current income and, secondarily, capital appreciation. Identify issues with above-average yields and the potential for capital appreciation.

- Conduct rigorous credit analysis to determine:
- Ability for issuer to pay debt on a timely basis
- Likelihood an issue will be upgraded to investment grade

Typically hold hundreds of individual issues to help reduce the impact of a single issue on fund performance.

BENEFITS AND RISKS

Significantly greater income potential than Treasury securities or investment-grade bonds in exchange for greater risk.


Effective portfolio diversification.

Definitions

Beta: A measure of market risk of an investment option that shows how responsive the investment is to a given market index, such as the Standard & Poor's 500 Index.
