INVESTMENT OBJECTIVE AND STRATEGY

The fund seeks to provide inflation protection and income by investing primarily in inflation-protected debt securities.

Normally invests at least 80% of its net assets in inflation-protected bonds, with emphasis on bonds issued by the U.S. Treasury (e.g. Treasury inflation-protected securities, or TIPS) but similar bonds issued by U.S. government agencies and corporations may also be purchased.

May invest up to 20% of its net assets in fixed-income securities that are not indexed to inflation or in preferred stocks and convertible securities rated BBB or better.

BENEFITS AND RISKS

Offers a way to get income potential and protect against inflation by helping preserve the purchasing power of your investment.

Invests in inflation-protected securities; the face value of these bonds and their income will rise with inflation.



Definitions

Beta: A measure of market risk of an investment option that shows how responsive the investment is to a given market index, such as the Standard & Poor's 500 Index. Morningstar rated the fund 4, 4, and 3 stars among 202, 179 and 124 Inflation-Protected Bond funds for the 3-, 5-, and 10-year periods (as applicable) ending 12/31/2021, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.
