## INVESTMENT OBJECTIVE AND STRATEGY

The fund seeks to provide preservation of capital, liquidity, and, consistent with these objectives, the highest level of income exempt from federal, New York state, and New York City income taxes.

Invests at least 65% of total assets in New York municipal securities that mature in 13 months or less. The fund will not have a weighted average maturity exceeding 60 days.

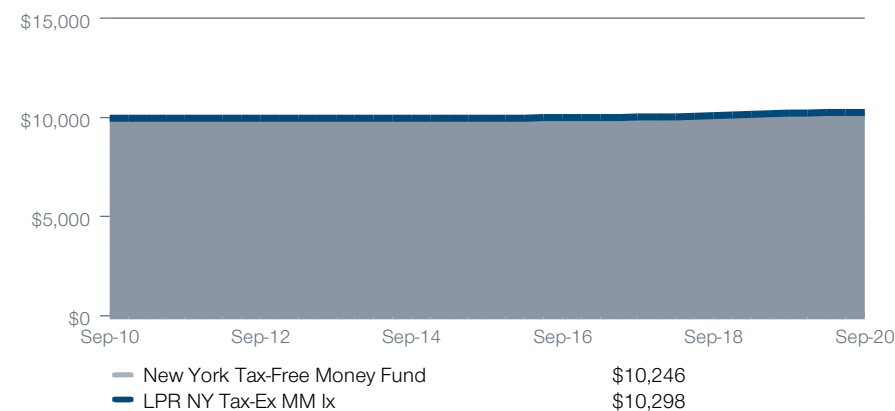
## BENEFITS AND RISKS
