
Investment Objective & Strategy

The fund seeks the highest total return over time consistent with a primary emphasis on capital growth and a secondary emphasis on income.

Invests in a diversified portfolio typically consisting of about 80% stocks; 16% bonds, money market securities, and cash reserves; and 4% alternative investments.

The manager can rebalance the investment mix, within defined ranges, based on the economic outlook, interest rates, and financial markets.

Morningstar rated the fund 4, 3, and 4 stars among 177, 173 and 143 Global Moderately Aggressive Allocation funds for the 3-, 5-, and 10-year periods (as applicable) ending 12/31/2025, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. Portfolio holdings in this report are presented gross of any non-reclaimable withholding tax. Any non-reclaimable withholding tax is included in position market values. Portfolio diversification data is calculated net of any non-reclaimable withholding tax. Any non-reclaimable tax withheld is not reflected in category market values.
