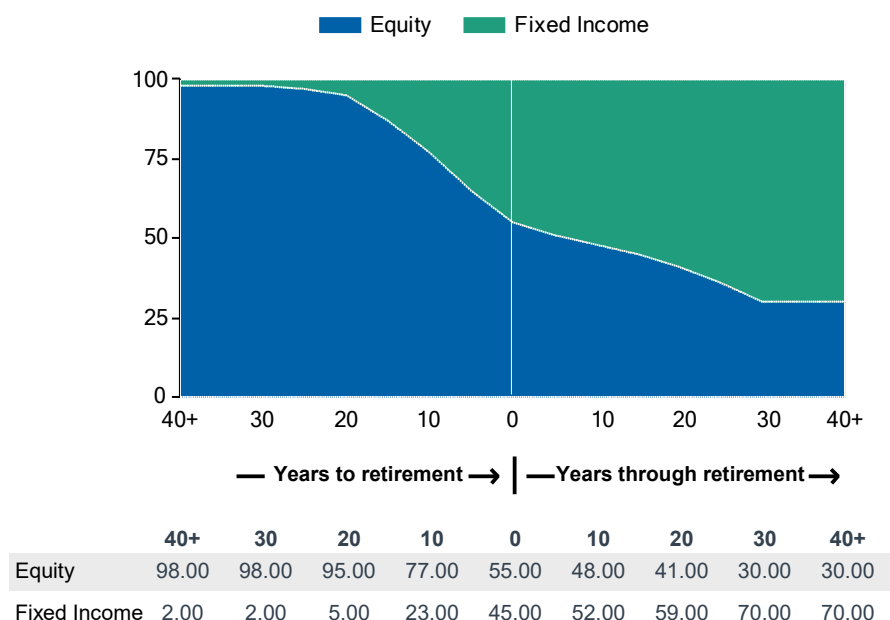
Investment Objective & Strategy
