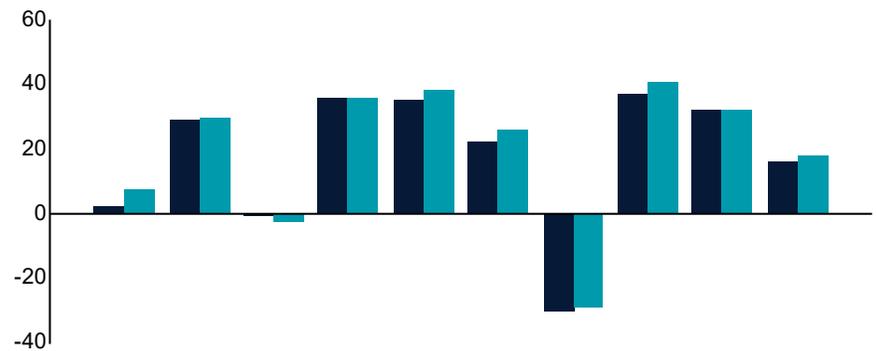
Seeks to maximize after-tax growth of capital by investing primarily in the common stocks of mid-size and, to a lesser extent, small companies.

The T. Rowe Price Fund shares the portfolio of an existing fund (the original share class of the fund is referred to as the "investor class"). The total return figures for this I Class have been calculated using the performance data of the Investor Class (incepted 12/29/00) up to the inception date of the I Class (7/6/17) and the actual performance results of the I Class since that date. Because the I Classes are expected to have lower expenses than the Investor Classes, the I Class performance, had it existed over the periods shown, would have been higher.

The after-tax returns presented reflect the return after taxes on dividends and capital gain distributions and the return after taxes on dividends, capital gain distributions, and gains (or losses) from redemptions of shares held for the time period shown, as applicable. After-tax returns reflect the highest federal income tax rate in effect at the time of each distribution but exclude state and local taxes. Morningstar rated the fund 3 and 3 stars among 1,004 and 936 Large Growth funds for the 3- and 5-year periods (as applicable) ending 12/31/2025, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.
