INVESTMENT OBJECTIVE AND STRATEGY

The fund seeks to provide high income consistent with maximum credit protection.

Invests at least 80% of its net assets in U.S. Treasury securities, which are backed by the full faith and credit of the federal government. The remainder is invested in other securities backed by the full faith and credit of the U.S. government.

The portfolio's weighted average maturity is expected to vary between 15 and 20 years, but may range from 10 to 30 years.

BENEFITS AND RISKS

Offers a way to receive monthly income through investments with the highest credit quality.

Typically provides higher income than short- and intermediate-term bond funds.

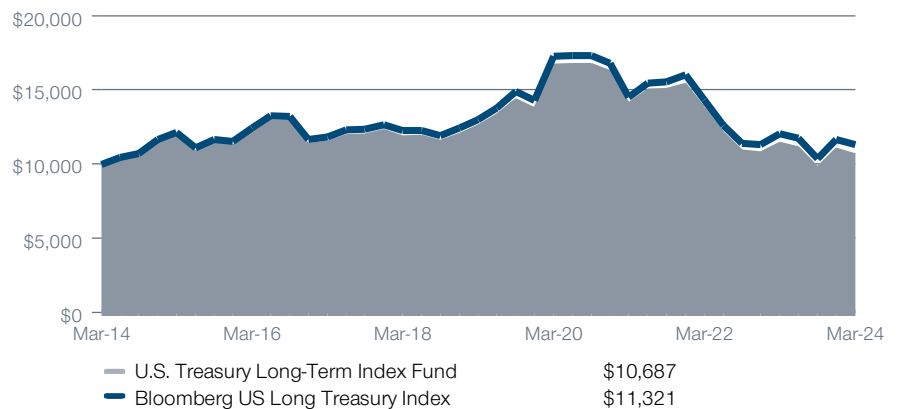
Minimal credit risk because it invests only in securities backed by the federal government and other investments involving such securities.

Primary source of risk is the possibility of rising interest rates. Long-term bonds are subject to the greatest price swings because the longer the maturity, the greater the price decline when rates rise and the greater the price increase when rates fall.

Index investments are passively managed and seek to match the performance of their benchmark; therefore, holdings generally are not reallocated based on changes in market conditions. As a result, the investment's performance may lag the performance of actively managed investments.

Definitions

Beta: A measure of market risk of an investment option that shows how responsive the investment is to a given market index, such as the Standard & Poor's 500 Index. By definition, the beta of the benchmark is 1.00. An investment with a beta of 1.10 is expected to perform 10% better than the index in up markets and 10% worse in down markets. Usually, higher betas represent riskier investments. Figures are calculated using monthly data and are net of fees.

Morningstar rated the fund 3, 3, and 3 stars among 37, 34 and 25 Long Government funds for the 3-, 5-, and 10-year periods (as applicable) ending 3/31/2024, respectively. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.
