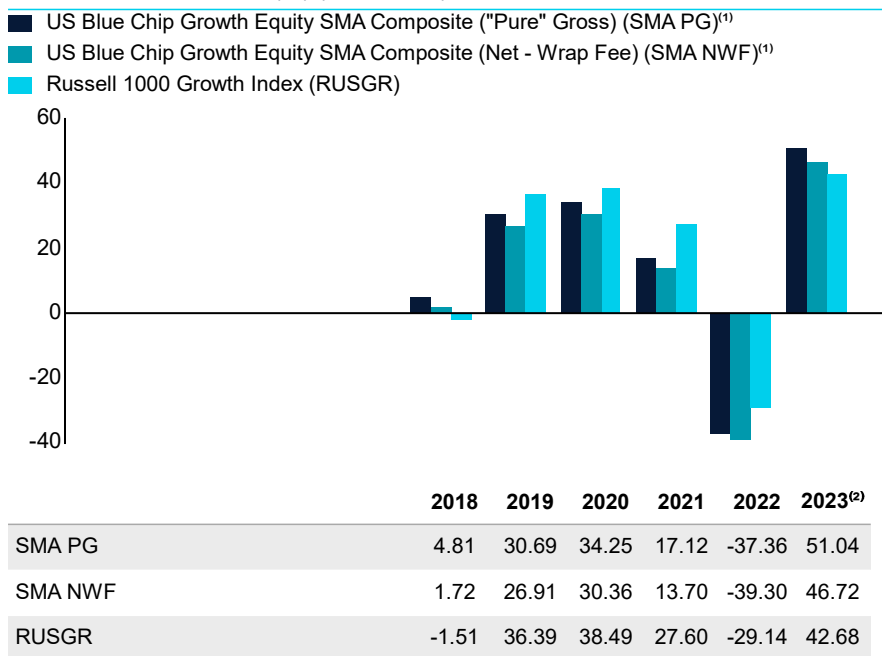

Avoid overpaying for growth, while broadly diversifying portfolios, to manage portfolio risk.
