Investment Objective & Strategy

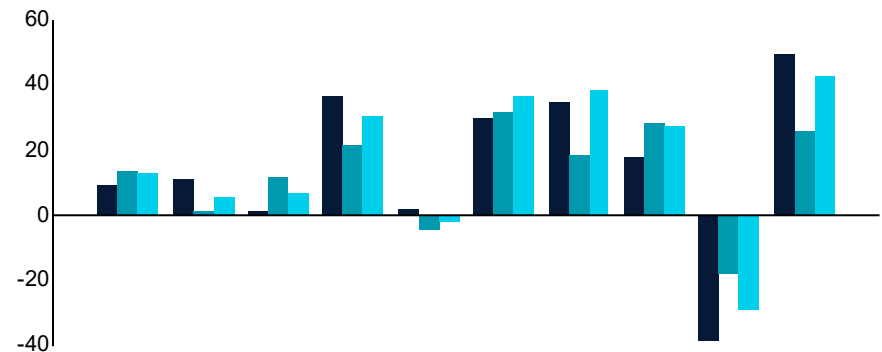
