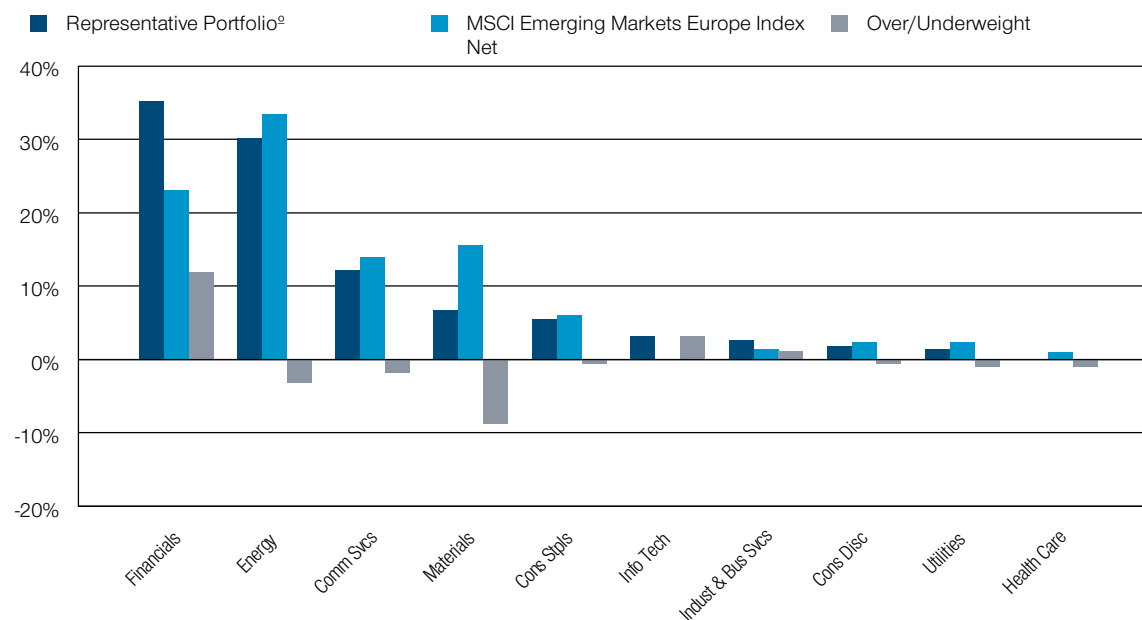

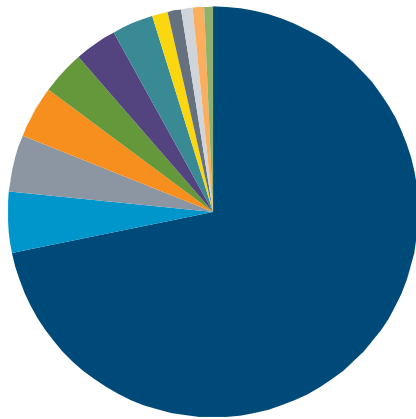

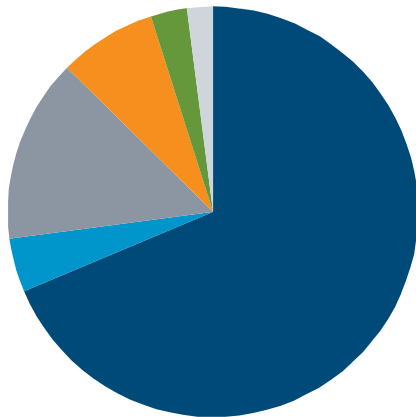
GEOGRAPHICAL DIVERSIFICATION

Representative Portfolio⁹



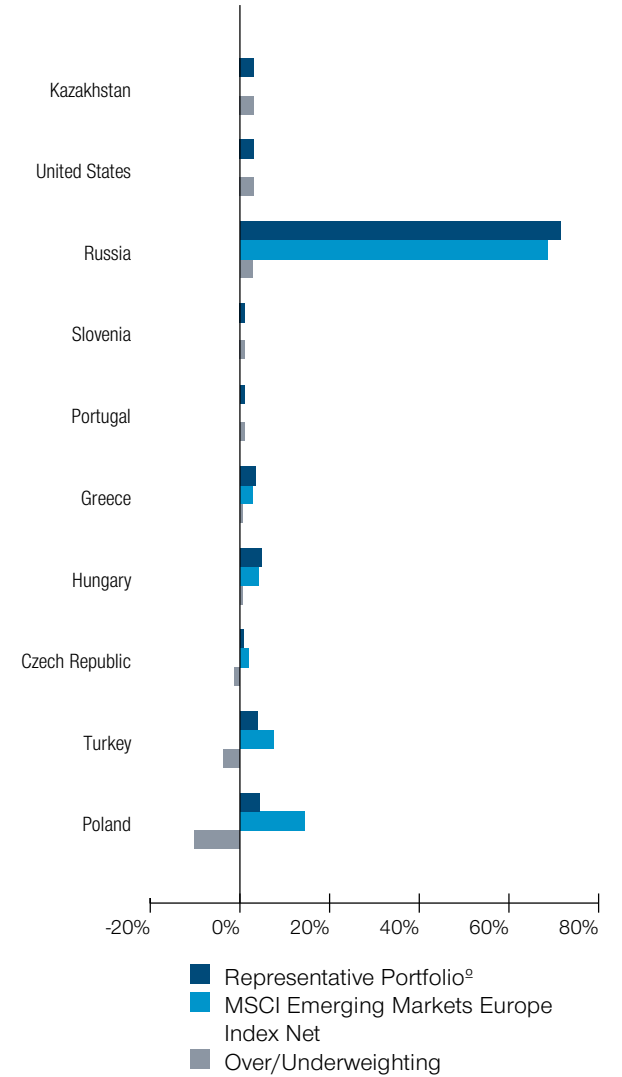

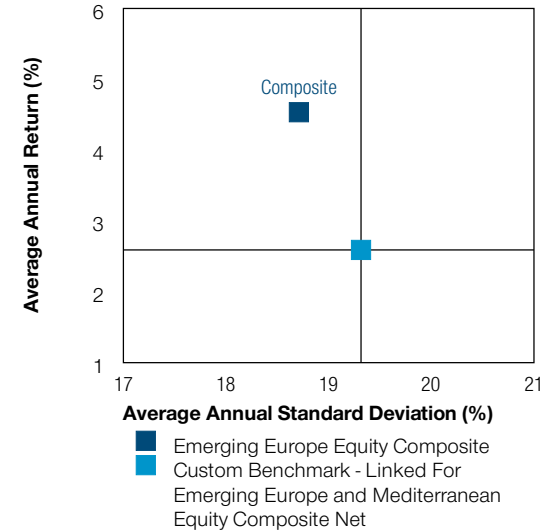
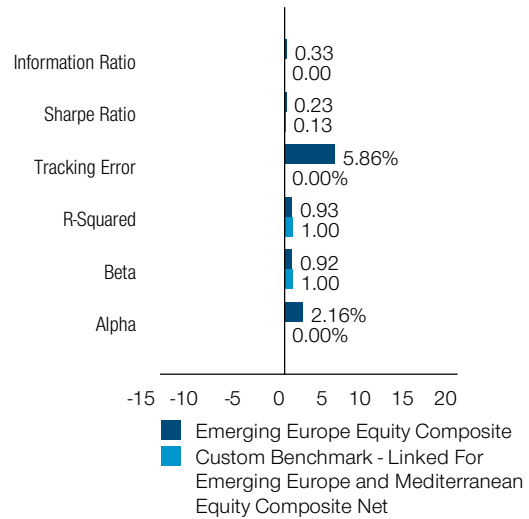
