INVESTMENT APPROACH

- Focus on companies within or below the market-cap range of the Russell 2000 Index at time of purchase.
- Assess valuation using relevant sector/industry metrics — absolute and relative price to earnings, price to cash flow, and price to assets.
- Integrate fundamental research to discover underfollowed companies possessing clear business plans, financial flexibility, and proven management teams.
- Identification of a “value creation” catalyst is key.
- Broadly diversify holdings to manage portfolio risk profile.
- Employ a low turnover and patient trading strategy to promote full value realization.

PORTFOLIO CONSTRUCTION

- Typically 275-300 securities
- Position sizes typically range between 0.15% and 2.50%
- Primary sector weights vary from 0.5X to 2.0X, relative to Russell 2000 Index weight

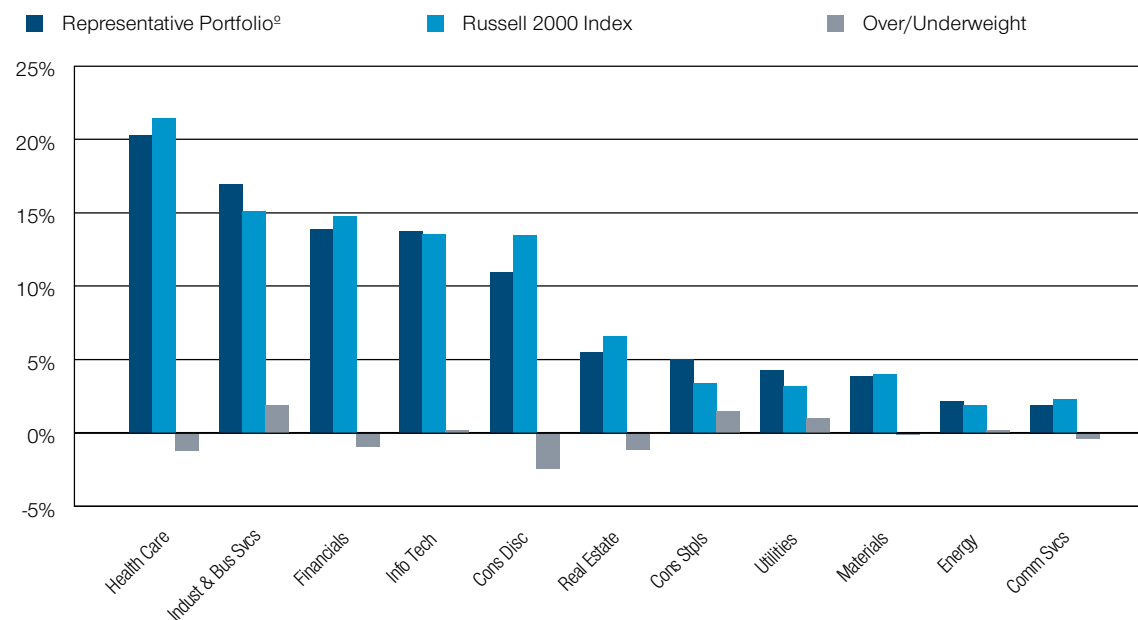

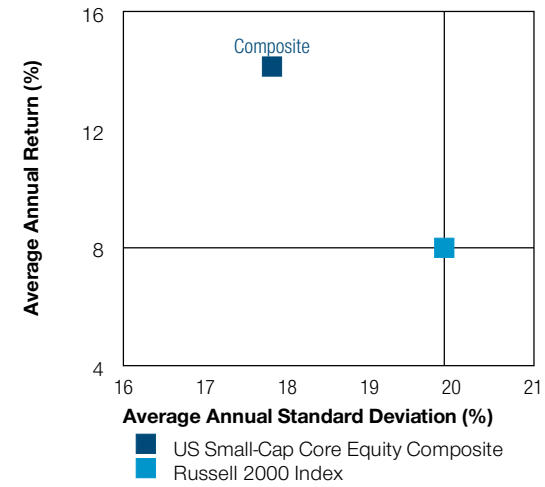
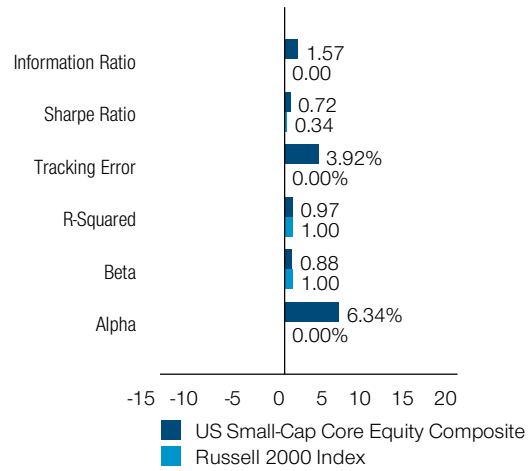

Valuations are computed and performance reported in U.S. dollars.

Effective June 30, 2013, portfolio valuation and assets under management are calculated based on the closing price of the security in its respective market. Previously portfolios holding international securities may have been adjusted for after-market events. Dispersion is measured by the standard deviation across asset-weighted portfolio returns represented within a composite for the full year. Dispersion is not calculated for the composites in which there are five or fewer portfolios.

The temporary removal of such an account occurs at the beginning of the measurement period in which the significant cash flow occurs and the account re-enters the composite on the last day of the current month after the cash flow.
