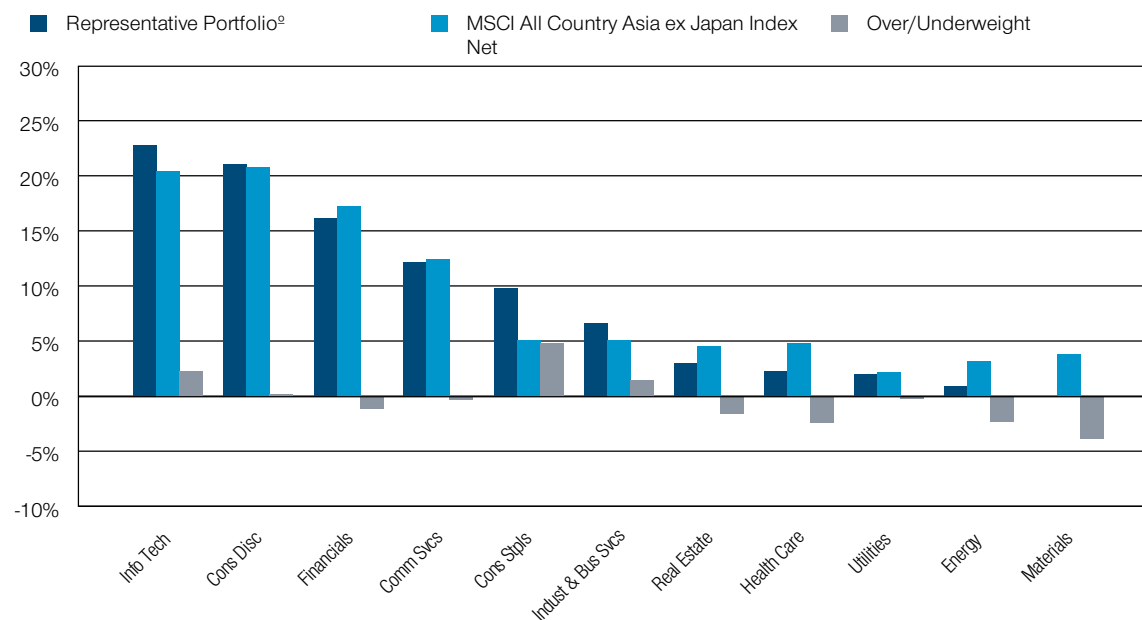

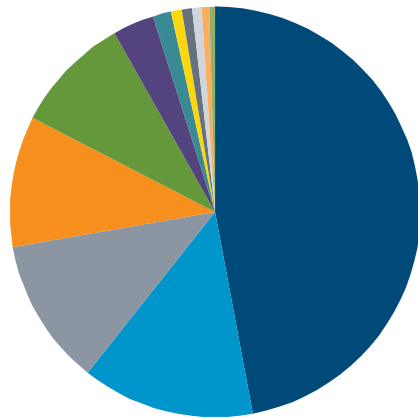

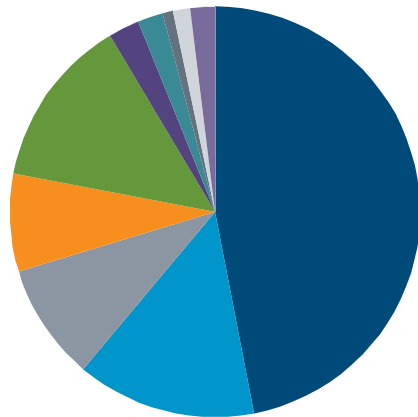
GEOGRAPHICAL DIVERSIFICATION

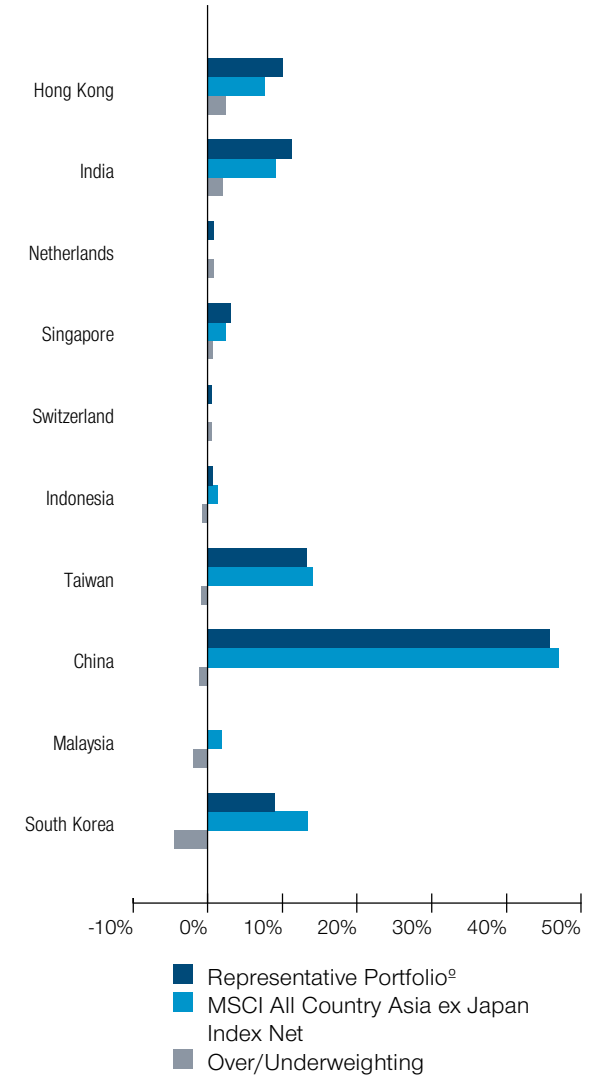

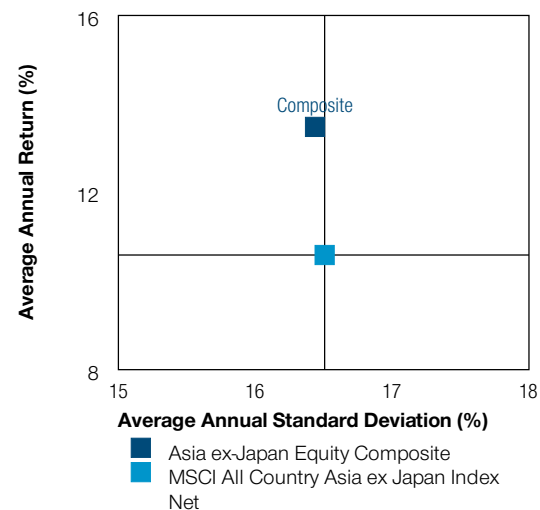
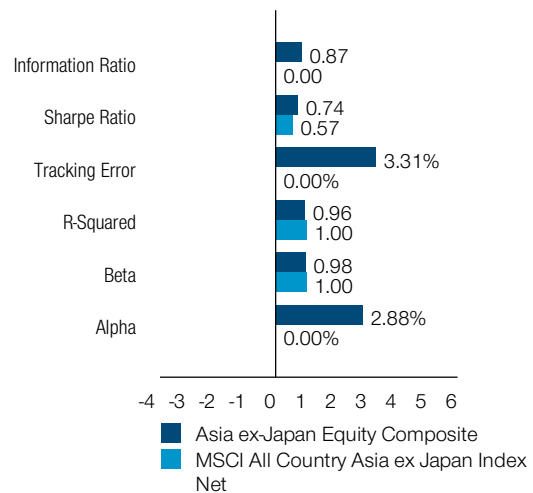
