- Sector, country, and regional allocations are driven by stock selection, as well as consideration of the broader macroeconomic environment.

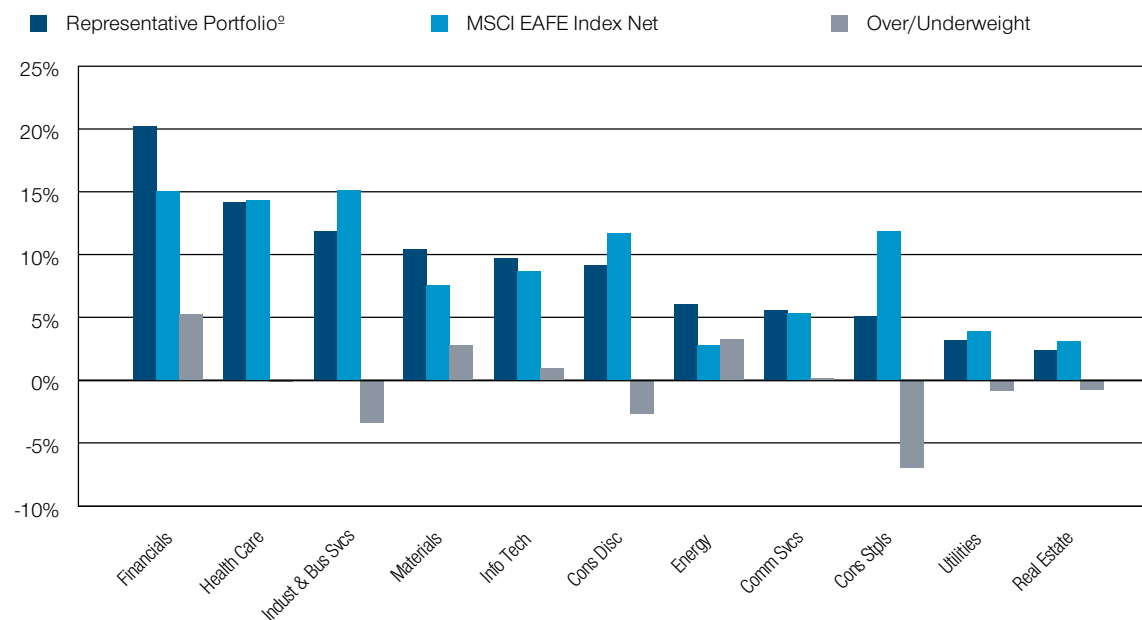

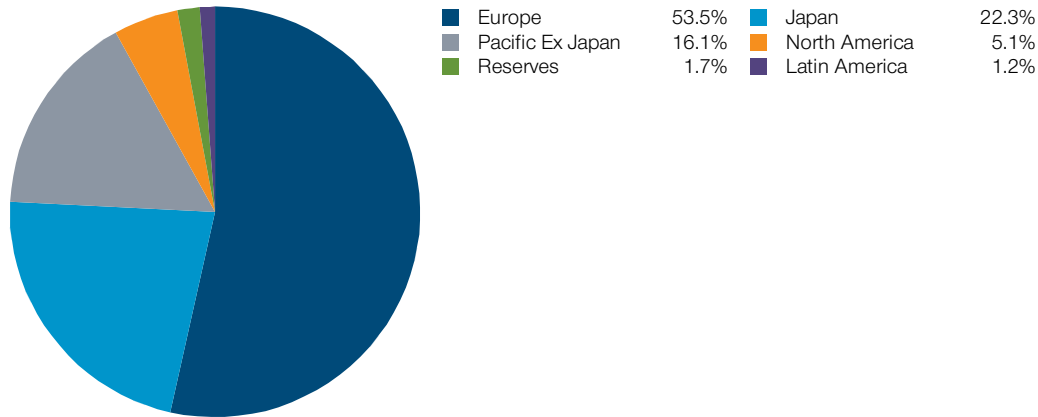

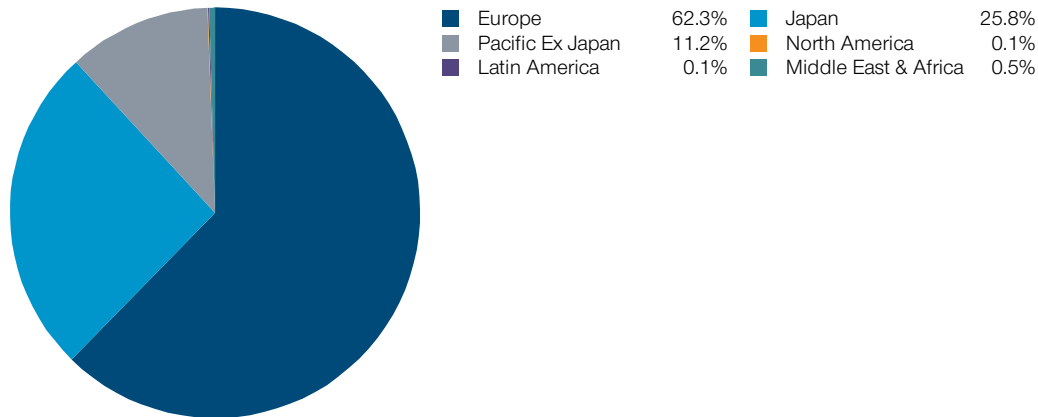

**Representative Portfolio<sup>9</sup>**

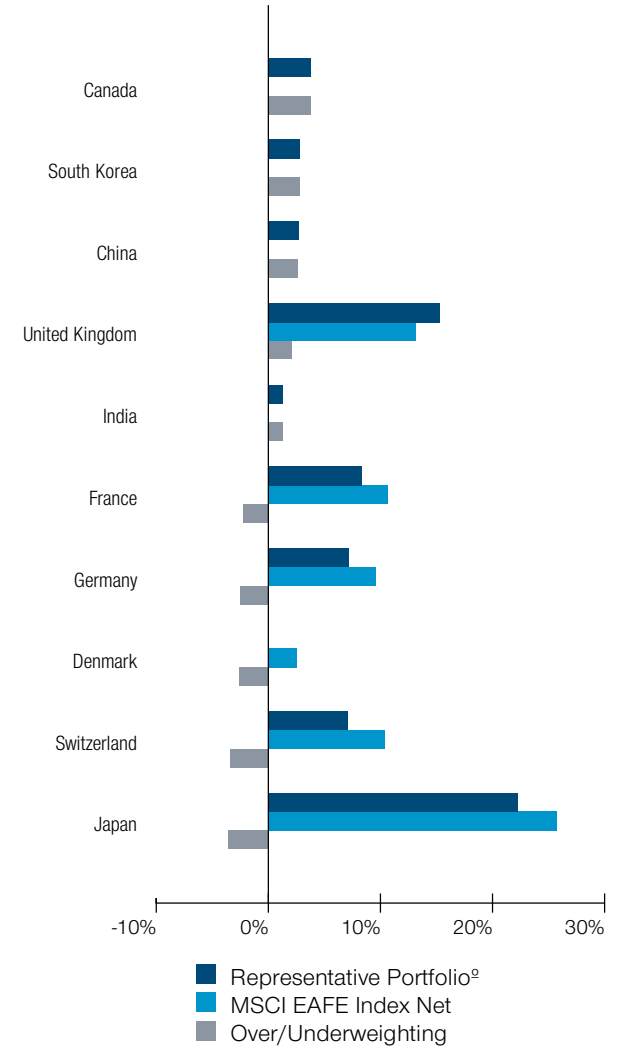


**MSCI EAFE Index Net**

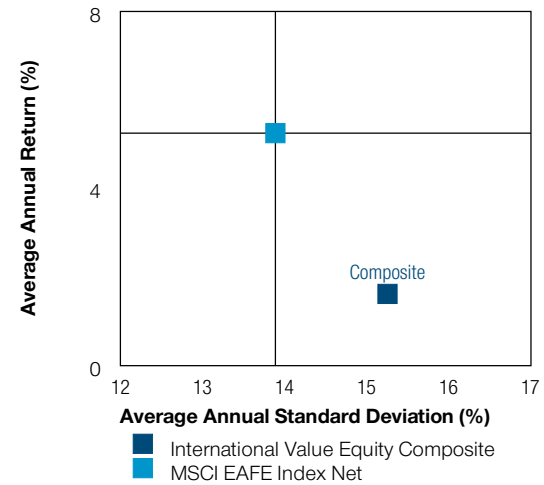
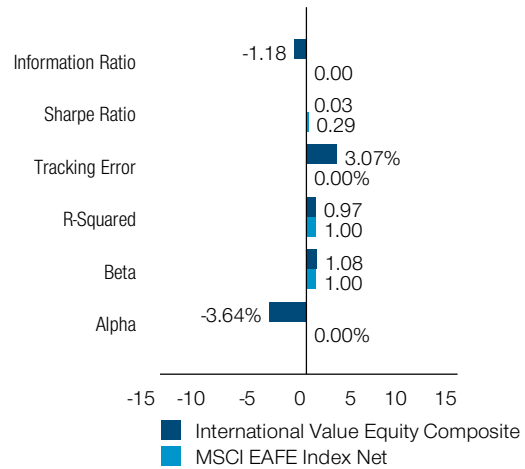
