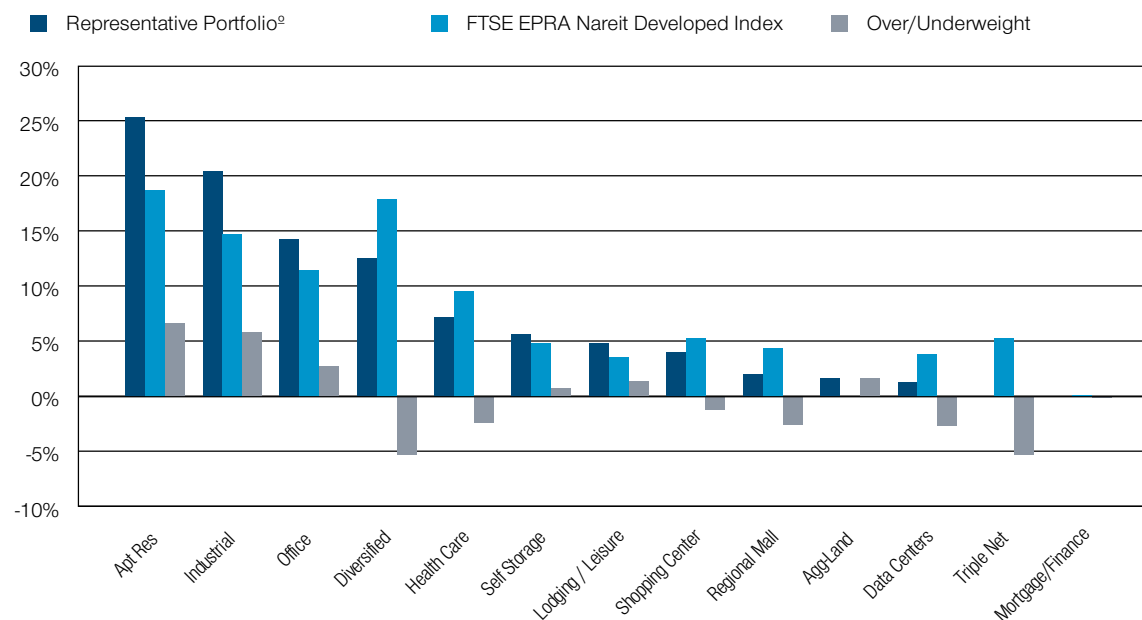

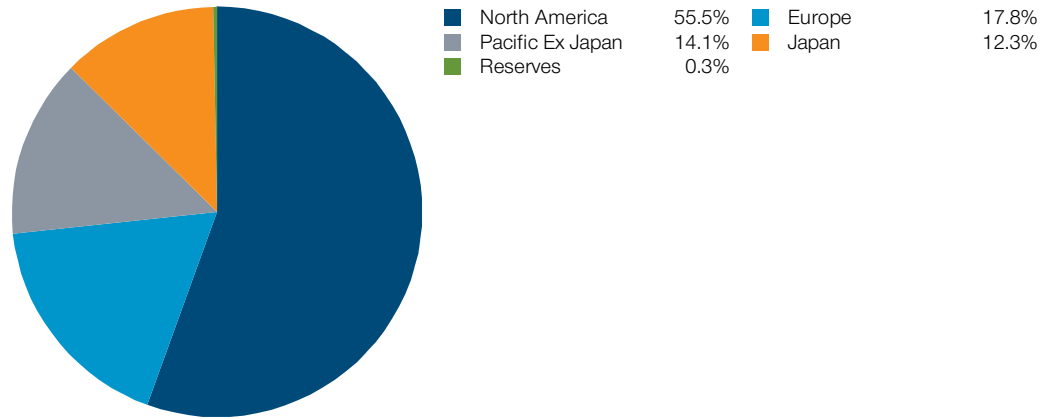

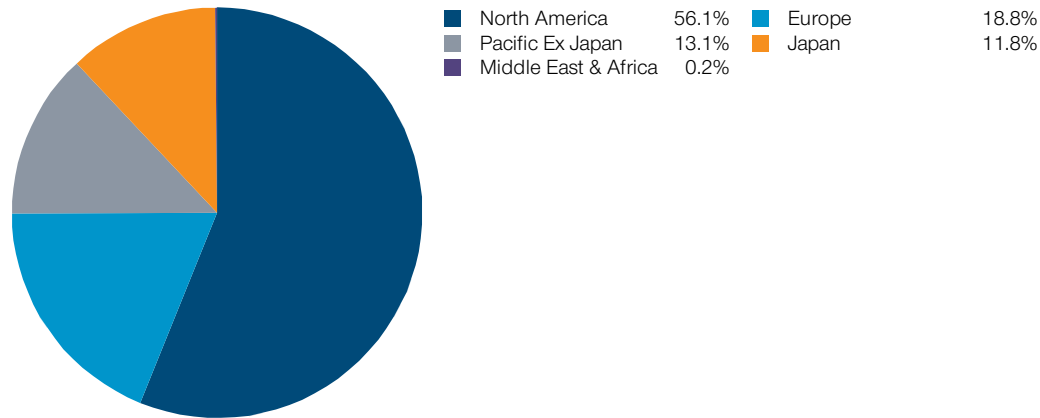

**Representative Portfolio<sup>9</sup>**

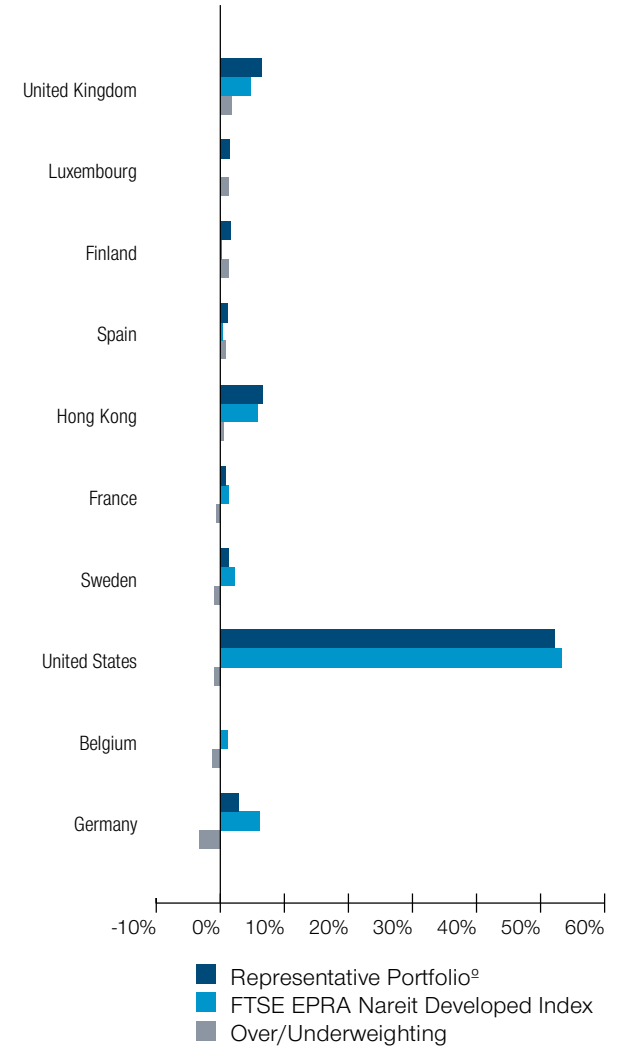


**FTSE EPRA Nareit Developed Index**

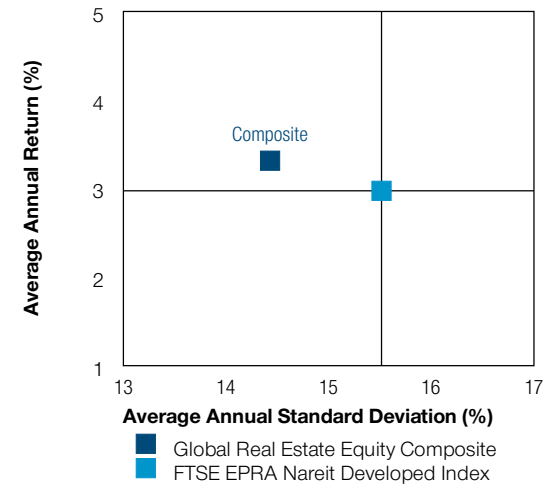
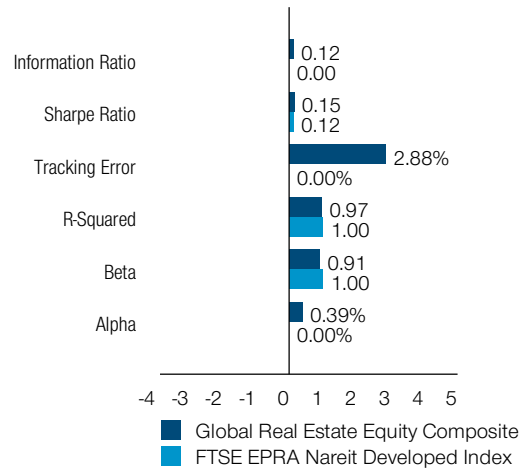

The temporary removal of such an account occurs at the beginning of the measurement period in which the significant cash flow occurs and the account re-enters the composite on the last day of the current month after the cash flow.
