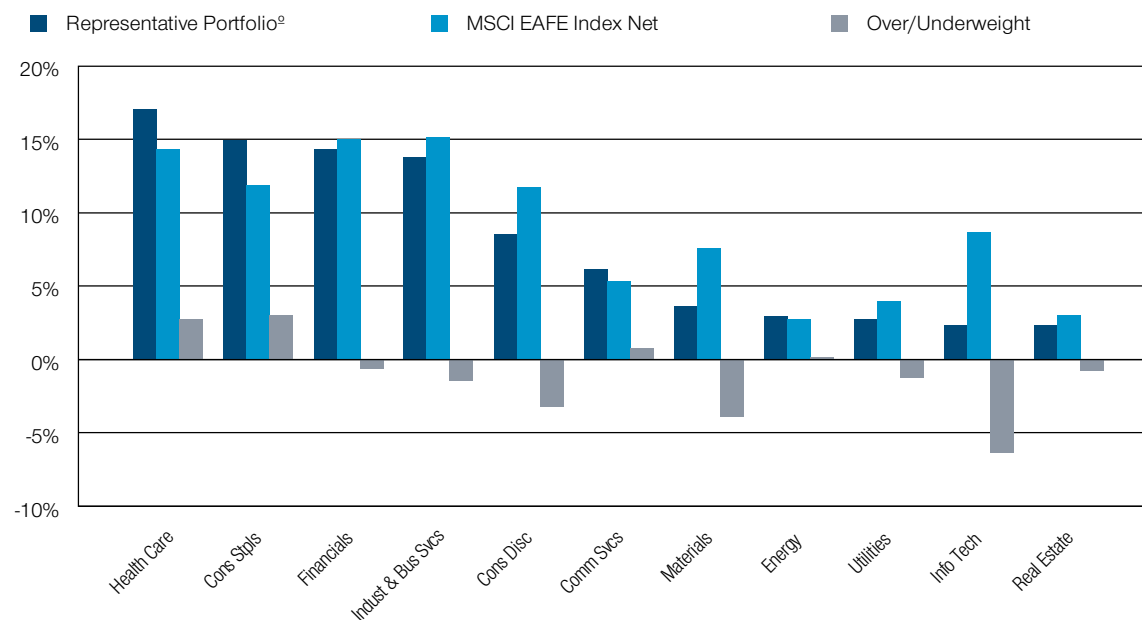

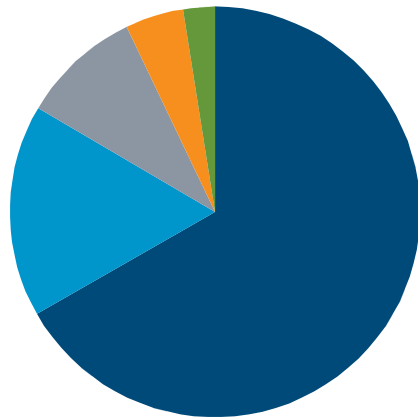

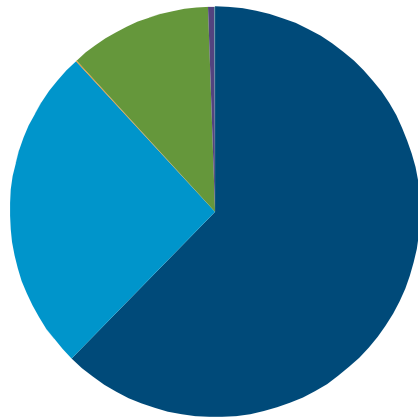
GEOGRAPHICAL DIVERSIFICATION

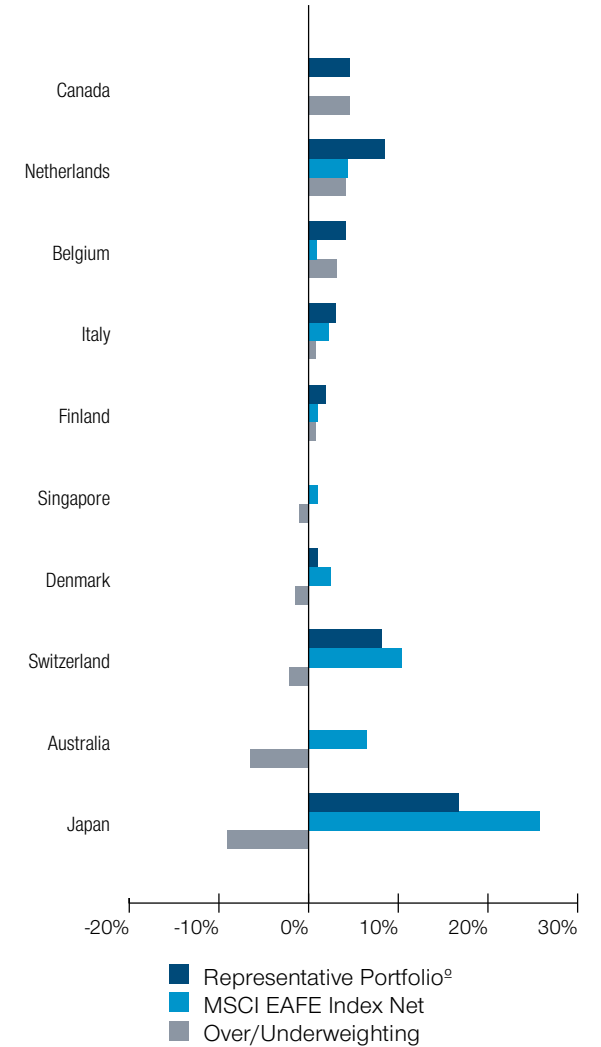
MSCI EAFE Index Net

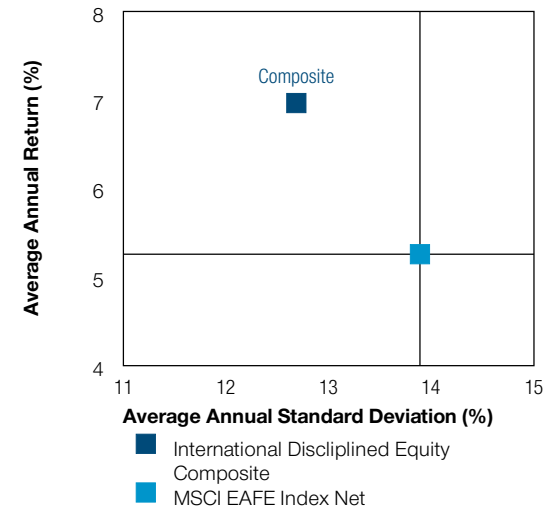
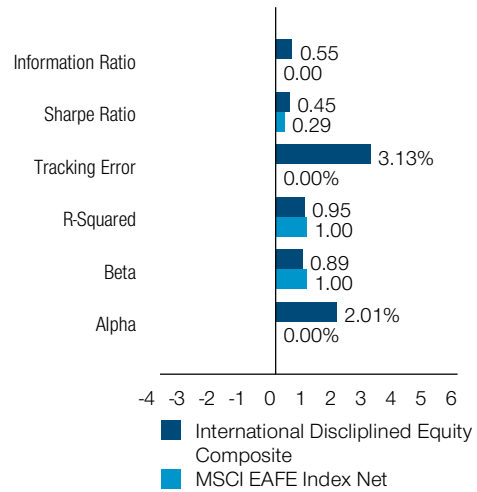
